At 7:00 p.m. Brad Burwell called the meeting to order and asked everyone to say the Pledge of Allegiance.

Roll call was taken and members present were: Mike Pate, Brad Burwell, Linda Poole, and Mike Kennedy. Absent were Julie Johnson and Jean Stothert.

### Superintendent's Report:

- 1. Tomorrow is Teacher's Appreciation Day and the staff will be given a free lunch at their schools, and at several other locations cookies will be provided.
- 2. There are only three candidates for the school board election, so there will be no need for the primary. Basically, the board is set.
- 3. The Foundation has chosen Julie Johnson as Millard Booster of the Year, and she will be honored at the Hall of Fame Banquet in May.
- 4. There will be no Committee meeting next week, because Bill Mueller, the district's lobbyist, is here this evening to talk about the legislative bills during the Legislative Update portion of the meeting.

Mike Kennedy expressed his thanks to the administration, Angelo Passarelli, Bill Mueller, and the state senators who are working so diligently in support of Millard in the takeover battle. Mr. Kennedy said he feels the community understands the Kopplin bill, which is good they recognize and understand what the District is doing.

Linda Poole also thanked the administration, and especially Senators Kopplin and Pahls because they have done an excellent job in leading the fight. She indicated that she received a call from someone in Lincoln, and was told that if nothing comes out of the Education Committee this week that Speaker Brashear may step up. She encouraged everyone in the community to contact the members of the Education Committee.

Mrs. Poole said she attended the NASB Legislative Issues Conference and on Sunday evening met with Mike Resnick, lobbyist from the National School Boards Association. During the time with Mr. Resnick they talked about their displeasure about NSBA not supporting Congressman Terry's bill on NCLB. Mr. Resnick explained that as a national association the bill doesn't have all the points that NSBA wants, so they can't come out and endorse one bill over another, but he will let Congressman Terry know that they do support what he is trying to do. Mr. Resnick talked to the whole conference group on Sunday evening. On Monday the speakers were Senator Raikes, Senator Petersen, and Senator Brashear on their perspective on the education issues in the State.

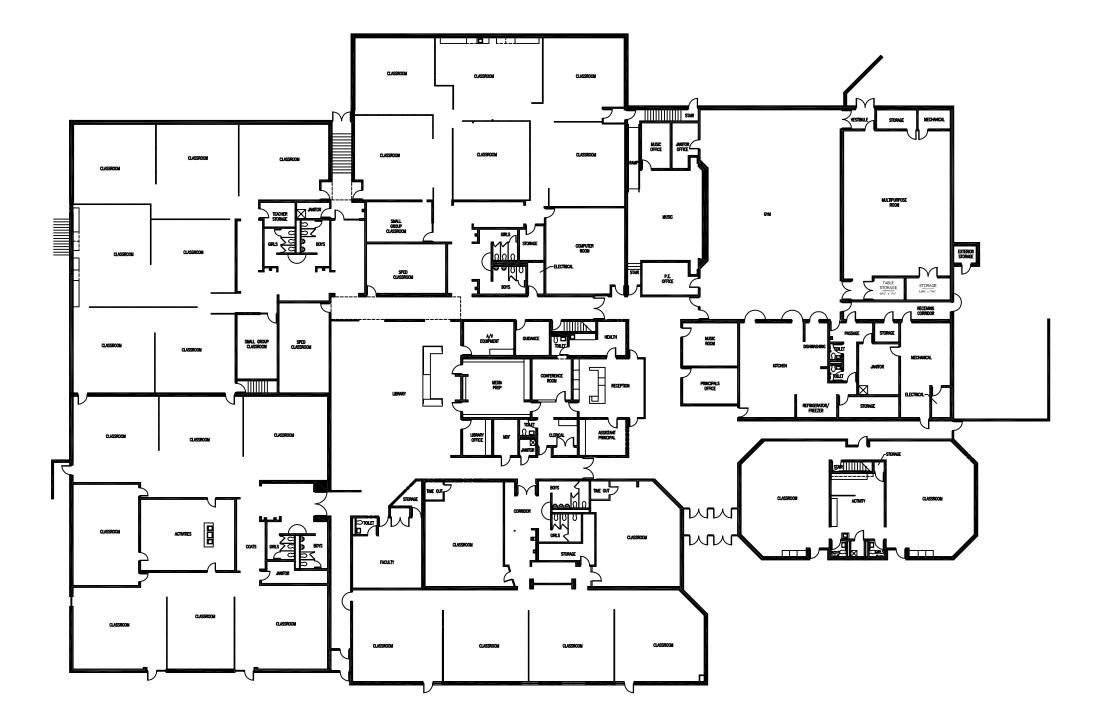

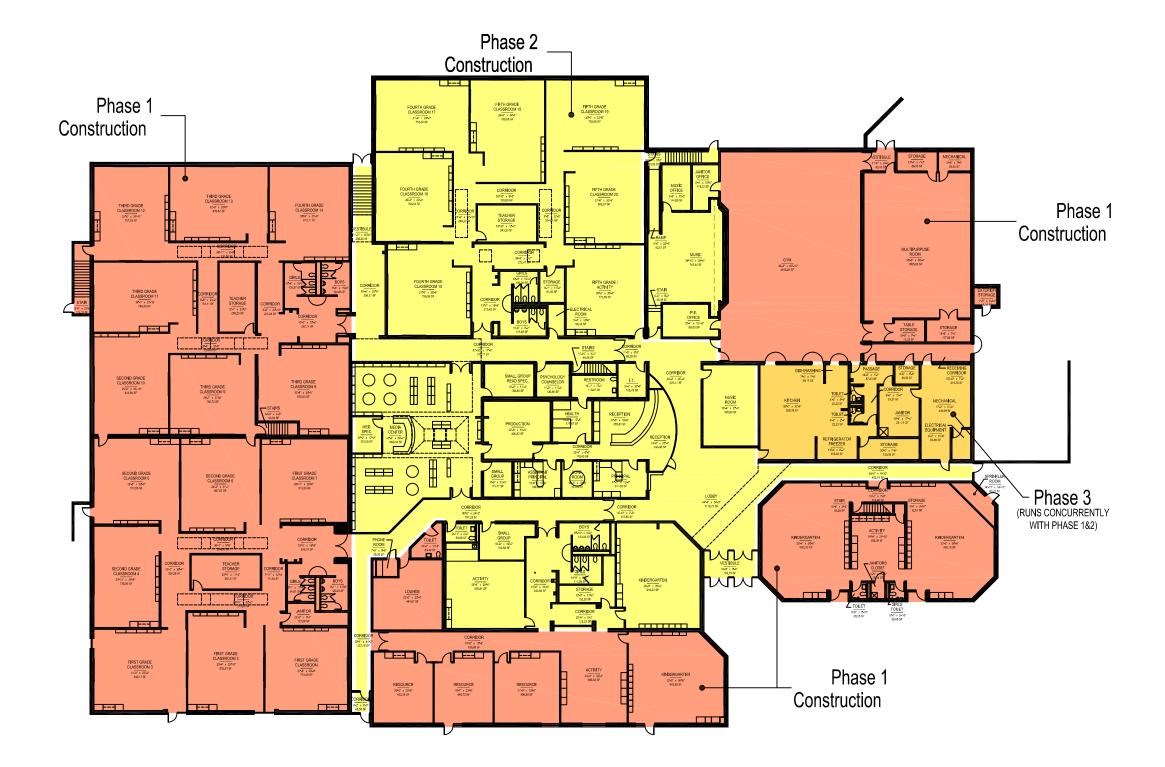










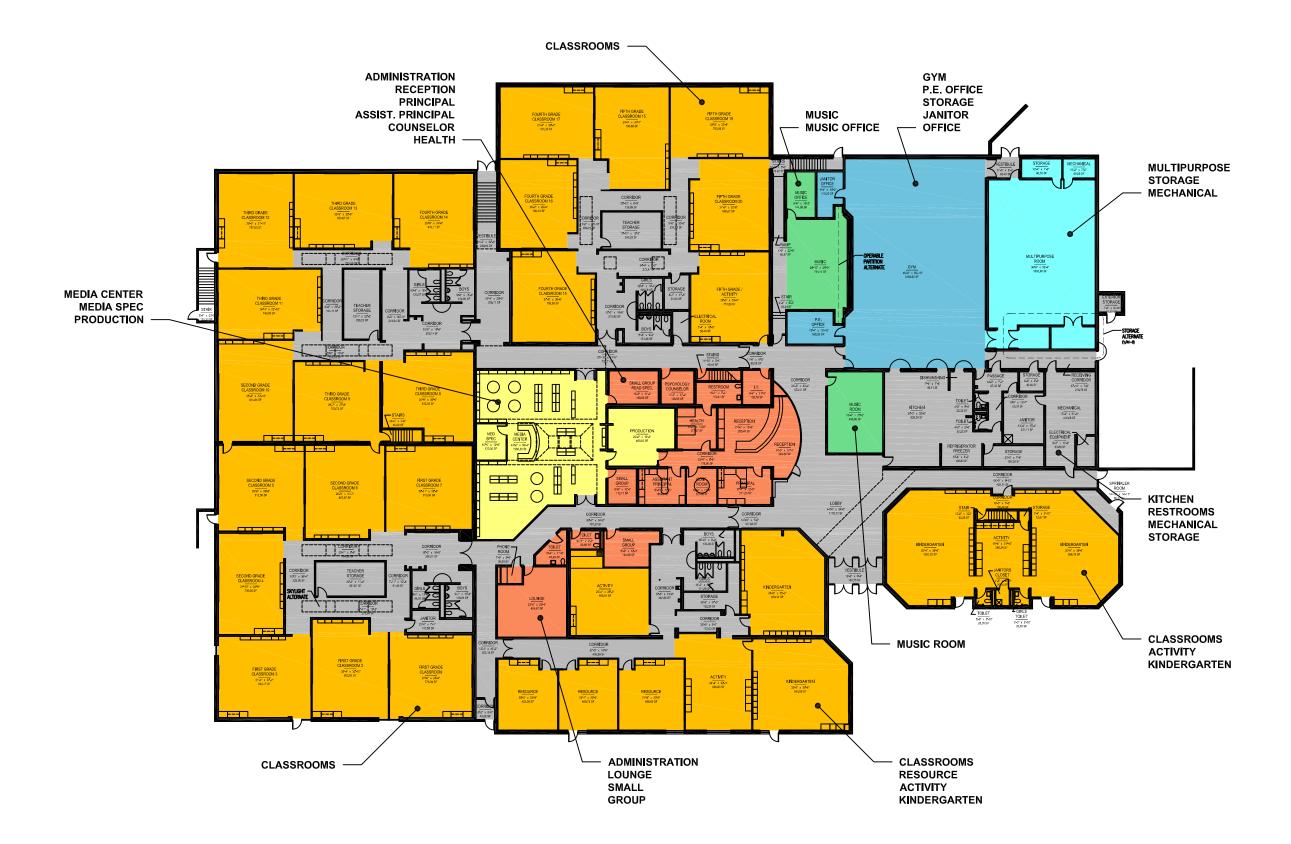

## **Conduct on District Property**

1235.1

- I. **Conduct of District Employees, Parents, and Visitors.** The District will promote in all District schools, facilities, and activities, an environment which is safe, free of disruption, and predicated by mutual respect, civility, and orderly conduct among District employees, students, parents, and visitors. District employees will demonstrate professionalism when communicating with the public or other District employees. District employees, parents, and other visitors will avoid disruptive, volatile, hostile, threatening, or aggressive communications or actions.
  - A. Expected Level of Behavior.
    - 1. District employees will treat parents, members of the public, and other District employees with courtesy and respect.
    - 2. Parents and other visitors to District schools, facilities, and activities will treat students, District employees, other parents, and other visitors with courtesy and respect.
  - B. Unacceptable/Disruptive Behavior.
    - 1. Disruptive behavior includes, but is not limited to, behavior which interferes with or threatens to interfere with the operation of a classroom, a District employee's duties, the functions of a school facility, District activities, or substantially interferes with the educational process.
    - 2. Using loud and/or offensive language, swearing, cursing, using profane language, or the display of anger.
    - 3. Threatening to do bodily or physical harm to students, District employees or other visitors on District property whether or not the behavior constitutes or may constitute a criminal violation.
    - 4. Damaging or destroying District property.
    - 5. Any other behavior that disrupts the orderly operation of a school, a school classroom, or any District facility or activity.
    - 6. Refusing to follow District safety instructions.
    - 7. Defaming District employees.
    - 8. Abusive, threatening, or obscene E-mail or voice mail messages.
    - 9. Sexual harassment of District personnel, students, patrons, or vendors is strictly prohibited. Sexual harassment shall include, but is not limited to, unwelcome sexual advances, requests for sexual favors and other verbal, nonverbal or physical conduct of a sexual nature.
  - C. Recourse. Any <u>employee</u>, parent or other visitor who believes he/she was subject to unacceptable/disruptive behavior from a District employee, <u>parent</u>, or <u>other visitor</u> should bring such behavior to the attention of the immediate supervisor, <u>building principal</u> or the <u>Director of Personnel Associate Superintendent for Human Resources</u>.

#### II. Authority of School Personnel.

- A. Authority to Direct Persons to Leave District Property and to Limit Communications or Monitor Communications with District Employees.
  - 1. Any individual who exhibits the following behaviors may be directed to leave District property by a principal, principal's designee or any District level administrator:
    - a. Disrupts or threatens to disrupt school or District activities or operations;
    - b. Threatens to or attempts to do or does physical harm to students, District employees, or other visitors;
    - c. Threatens the health or safety of students, District employees, or other visitors;
    - d. Intentionally causes damage to a school, District property, or property of other visitors;
    - e. Uses loud or offensive language;
    - f. Defames District employees;
    - g. Who without authorization comes onto District property.
  - 2. If the person refuses to leave the premises as directed, the administrator or other authorized personnel shall call 911 for law enforcement assistance.
  - 3. If a visitor uses obscenities or speaks in a demanding, loud, insulting, and/or a demeaning manner, the District employee to whom the remarks are directed will follow these procedures:
    - a. Shall calmly and politely warn the speaker to communicate civilly.
    - b. If such conduct continues, the District employee to whom the remarks are directed may, after giving appropriate notice to the speaker, terminate the meeting, conference, or telephone conversation.
    - c. If the meeting or conference is on District property, any District employee may request that an administrator or other authorized personnel direct the speaker to promptly leave the premises.
    - d. If the person refuses to leave the premises as directed, the principal or designee or a District level administrator may call 911 for law enforcement assistance.
    - e. If the District employee is threatened with personal harm, the District employee may call 911 for law enforcement assistance.
- B. Authority to Report or Terminate Phone or E-mail Communication.

- 1. If any District employee receives an E-mail or voice mail message that is abusive, threatening, or obscene, the District employee is not obligated to respond to the E-mail or return the telephone call.
- 2. The District employee should save the message and contact their supervisor. If the message threatens personal harm, the District employee may contact law enforcement.

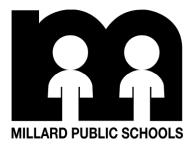

### **Instructional Approaches**

Scientific inquiry is the foundation of science education. All strands of science include the scientific methods and process skills on a daily basis. The methods and skills listed below are integrated throughout all units of elementary science.

#### Grade K-2

- Scientific Methods are organized ways of finding answers and solving problems. Scientific methods include certain parts, the order of how the parts are used can be changed. The scientific method includes: ask question; make your hypothesis; plan a fair test; do your test; collect and record your data; tell your conclusion; and go further
- Process Skills are used throughout science activities. The process skills include: observing; communicating; classifying; estimating and measuring; inferring; predicting; making and using models; making operational definitions; forming questions and hypotheses; collecting data; interpreting data; identifying and controlling variables; and investigating and experimenting.

### Grades 3-5

- Scientific Methods are organized ways of finding answers and solving problems. Scientific methods include certain parts, the order of how the parts are used can be changed. The scientific method includes: problem; give your hypothesis; control the variables; test your hypothesis; collect your data; tell your conclusions; and inquire further.
- Process Skills are used throughout science activities. The process skills include: observing; communicating; classifying; estimating and measuring; inferring; predicting; making and using models; making operational definitions; forming questions and hypotheses; collecting data; interpreting data; identifying and controlling variables; and investigating and experimenting.

Teaching standards for elementary science encompass the following:

- 1. Understanding and responding to individual student's interests, strengths, experiences, and needs
- 2. Selecting and adapting curriculum
- 3. Focusing on student understanding and use of scientific knowledge, ideas, and inquiry processes.
- 4. Guiding students in active and extended scientific inquiry.
- 5. Providing opportunities for scientific discussion and debate among students.
- 6. Continuously assessing student understanding.
- 7. Sharing responsibility for learning with students.
- 8. Supporting a classroom community with cooperation, shared responsibility, and respect.
- 9. Working with other teachers to enhance the science program.

Suggestions for engaging a diverse student body in high-quality science education:

- 1. Guide students as they begin to engage in the inquiry process.
- 2. Make information resources available in multiple formats.
- 3. Give students opportunities to express their ideas in multiple formats.
- 4. Make the process of investigation fully accessible
- 5. Make role models available.
- 6. Use technology that is accessible for all.
- 7. Make assistive technology available when necessary
- 8. Emphasize cooperation and collaboration

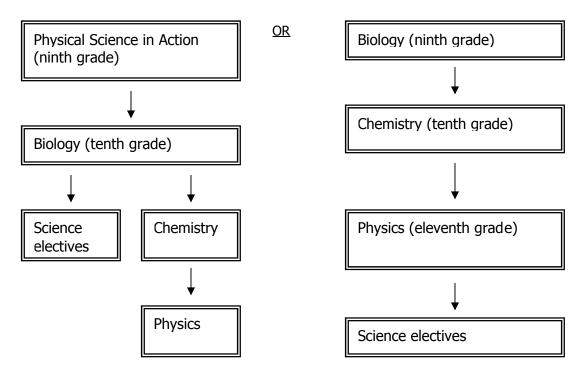

### **High School Science:**

### Recommendations for Sequence of High School Science Courses



Most students should take Physical Science in Action in ninth grade, followed by Biology in tenth grade. Other physical science (including Chemistry and Physics) and life science courses are available as electives to round out the student's understanding of life, physical, earth and space science.

Students wanting to accelerate their science curriculum may take Biology in ninth grade. It is recommended that they take Chemistry in tenth grade, followed by Physics in eleventh grade. The purpose of starting with Biology in ninth grade is to provide students who have a strong interest in science the opportunity to take more than two and a half years of science in high school, including Advanced Placement® science courses.



### **Course:** Kindergarten Science

### **Life Science - Kindergarten**

### Outcome 1

Students will identify: what plants and animals need; how plants and animals grow and change, and where plants and animals live.

### **Essential Questions:**

- What do plants and animals need?
- How do plants and animals grow and change?
- Where do plants and animals live?

### **Enduring Understandings:**

- Living things can move, grow, and change. Plants and animals are examples of living things. Nonliving things cannot move, grow, or change on their own. Boats and stools are examples of nonliving things. All living things have needs. Living things need air, water, food, light, space and shelter
- Animals grow and change in different ways. Animals walk, run, fly, swim or crawl to move. Plants grow from seeds. Seeds that are planted grow into plants. Plants grow in size over time.
- Plants and animals live on land or in water. Special types of plants and animals can be found in hot and cold places.

### **Outcome Assessment: Select one**

- Performance Assessment Build a model of a plant.
- Full Inquiry Experiment What do seeds need to grow?

### **Earth Science - Kindergarten**

### Outcome 2

Students will identify: how we use land, water, and air on Earth; what weather is like in each season.

#### **Essential Questions:**

- How do we use land, water, and air on Earth?
- What is the weather like in each season?

### **Enduring Understandings:**

- The Earth's land is made up of sand, pebbles, soil and rocks. Earth's land has mountains, valleys, and plains. People use the Earth's land in many ways to meet their needs. People can help protect the Earth by the way they use and reuse it. The Earth's water comes in different forms in streams, rivers, lakes and oceans.
- The Earth's many types of weather that can change ail. The Earth has four seasons-spring, summer, fall and winter- that have their own characteristic weather ecological features. Storms may have rain, wind, thunder and lightning. Big storms include tornados and hurricanes.

### **Outcome Assessment: Select one**

- Performance Assessment Make a diorama of a part of Earth, showing land, water, and sky.
- Full Inquiry Experiment How strong is the wind?



### **Physical Science - Kindergarten**

#### Outcome 3

Students will identify: how you describe things; what gives us heat and light; how things move.

#### **Essential Questions:**

- How can we describe objects?
- What gives us heat, light, and energy?
- How do things move?

### **Enduring Understandings:**

- Objects can be described by their size, shape, color, texture, weight, and other physical features.
   Matter can be in the form of solids, liquids, or gases. The three forms of matter can be changed in different ways. Solids have a definite shape, liquids can change shape, and gases can change shape and size. The forms of matter can be changed in different ways. Solids can be folded, cut, mixed, melted, and bent. Liquids can be frozen or changed into gases.
- The Sun gives heat and light and can warm and melt things. The light of the Sun can pass through certain objects but not others. It makes a shadow if it cannot pass through an object. Things other than the Sun, such as stoves, can give off heat. Rubbing hands together creates friction that produces heat. Energy to power things can come from the Sun, batteries, and electricity.
- Objects can be moved by pushing or pulling them. Things can move in different directions and to many places. Some things can roll, some can twirl, some can slide, and some can slide. Things can move fast or slow. Sound is caused by vibrations. We hear sounds through the ears and the brain.

- Performance Assessment Change a solid.
- Full Inquiry Experiment Which melts first?

#### **Space and Technology - Kindergarten**

#### Outcome 4

Students will identify: how night and day are different, how we use machines

### **Essential Questions:**

- How are day and night different?
- How do we use machines?

### **Enduring Understandings:**

- During the day, the Sun, clouds, planes, birds, and other things may be seen in the sky.
- At night, the stars and Moon may be seen in the sky. The nighttime sky is dark, but the daytime sky is light.
- The Sun repeats the pattern of rising in the east, moving across the sky, and setting in the west every day.
- The Moon has phases that make it look like its shape is changing because light is reflected on different parts of the Moon.
- People use simple machines, such as a lever, ramp, pulley, and wheel, to help them do things.
- Children and their families use many different kinds of machines to help them every day. These machines are made up of different parts and materials.
- People use some machines, such as cars, trains, buses and planes, to go from place to place.
- People use machines to make work easier and to help them enjoy recreational activities.

### **Essential Questions:**

- How do plants live in their habitats?
- How are animals different from each other?
- How do living things help each other?
- How do living things grow in different ways?

### **Enduring Understandings:**

- Plants have adaptations that help them live in different environments.
- Animals can be put into two groups. One group of animals has backbones. The other group of animals
  does not have backbones.
- Living things help each other in different ways. Animals and plants that need each other for food are part of a food chain.
- Living things have different life cycles. A life cycle is the way a living thing grows and changes. Plants and animals have life cycles.

#### **Outcome Assessment: Select one**

- Full Inquiry Experiment Which bird beak can crush seeds?

### Earth Science - Grade 2

- How does weather change?
- How can people learn about Earth long ago?

### **Enduring Understandings:**

- Sunlight, air, and water are some of Earth's natural resources.
- Weather can change from day to day. Different seasons have different kinds of weather.
- People study fossils to learn about plants and animals that lived on Earth long ago.

#### **Outcome Assessment: Select one**

- Performance Assessment Make a model of water erosion.
- Full Inquiry Experiment Does gravel, sand, or soil make the best imprint?



### Physical Science - Grade 2

### Outcome 3

Students will identify: properties of matter; list kinds of energy; how forces cause objects to move; how sound is made.

### **Essential Questions:**

- What are some properties of matter?
- What are some kinds of energy?
- How do forces cause objects to move?
- How is sound made?

### **Enduring Understandings:**

- Some properties of matter are color, shape, and size. How much something weighs and how it feels are also properties of matter.
- Solar energy, light, and electricity are some kinds of energy.
- The amount of force used on an object affects how far and how fast the object moves.
- Sound is made when an object vibrates. Loudness is how loud or soft a sound is. Pitch is how high or low a sound is.

### **Outcome Assessment: Select one**

- Performance Assessment Make a musical instrument.
- Full Inquiry Experiment What kinds of objects reflect light clearly?

### Space and Technology - Grade 2

### Outcome 4

Students will identify: ways that the Earth moves; list ways that technology helps us.

### **Essential Questions:**

- What are some ways the Earth moves?
- What are some ways technology helps us?

### **Enduring Understandings:**

- Earth is always spinning on its axis. Earth moves around the Sun in an orbit.
- Technology helps people travel, communicate, and make things.
- Doctors use technology to help people get well.

### <u>Life Science – Grade 3</u>

### Outcome 1

Students will identify: how different parts of a plant help it live and grow; how different animals live, grow, and change; list major types of ecosystems.

#### **Essential Questions:**

- How do the different parts of a plant help it live and grow?
- How do different animals live, grow, and change?
- What are some major types of ecosystems?

### **Enduring Understandings:**

- Most plants have roots, stems, leaves, and flowers. Each kind of part helps the plant grow, make food
  or make seeds. Some kinds of plants have flowers. Other kinds have cones.
- All animals begin as eggs. The eggs of some animals develop inside the mother while other animals lay eggs that hatch outside the mother. Some young animals look like their parents. Other young animals must go through different stages of growth before they look like their parents.
- Grasslands, deserts, tundra, evergreen forests, broadleaf forests, and tropical forests are land ecosystems. Lakes, ponds, rivers, streams, and oceans are water ecosystems.

#### **Outcome Assessment: Select one**

- Performance Assessment Group materials for making food.
- Full Inquiry Experiment How can a garden spider move across its web?

#### Earth Science - Grade 2

#### Outcome 2

Students will identify: what makes water so important on Earth; how weather follows patterns; why rocks and soil are important resources; how forces cause change on Earth's surface; how people use natural resources responsibly.

### **Essential Questions:**

- What makes water so important on Earth?
- How does weather follow patterns?
- Why are rocks and soil important resources?
- How do forces cause change on Earth's surface?
- How can people use natural resources responsibly?

### **Enduring Understandings:**

- Living things need water to survive. People use water in many ways. Water can change from liquid to solid to water vapor.
- Weather patterns in a place are caused by the Sun heating the Earth and the water cycle.
- Knowing about weather patterns helps people predict the weather and be safe.
- Igneous, sedimentary, and metamorphic rocks are made of minerals. Soil covers most of Earth's land and is made of bits of rock, water and humus.
- The movements of Earth's plates can cause volcanoes and earthquakes to change Earth's surface quickly. Earth's surface can be changed slowly by weathering and erosion.
- People can plant trees to replace ones they cut down and do things to make soil healthy and useful
  again. People can conserve natural resources by reducing the amount of resources they use and trash
  they make. They can also reuse and recycle materials.



#### **Outcome Assessment: Select one**

- Performance Assessment Identify changing forms of water.
- Full Inquiry Experiment What settles first?

### Physical Science – Grade 3

### Outcome 3

Students will identify: properties of matter; list physical and chemical changes in matter; how forces cause motion and get work done; how energy changes form; how energy produces the sound we hear.

#### **Essential Questions:**

- What are the properties of matter?
- What are physical and chemical changes in matter?
- How do forces cause motion and get work done?
- How does energy change form?
- How does energy produce the sounds we hear?

### **Enduring Understandings:**

- Matter takes up space, has weight, and has properties that can be observed. Mass, volume, density, and buoyancy are properties of matter that can be measured.
- Matter can change the way it looks during a physical change. During a chemical change, matter changes into a new kind of matter.
- Forces cause a change in motion and work to be done by changing an object's speed or direction. Pushes and pulls change motion only by touching objects. The forces of gravity and magnetism can change an object's motion without touching it.
- The two main kinds of energy are potential and kinetic. Light, electrical, thermal, sound, chemical, mechanical, and magnetic are different forms of energy that can change form.

#### **Outcome Assessment: Select one**

- Performance Assessment Identify electric charges.
- Full Inquiry Experiment How does energy affect the distance a toy car travels?

### **Space and Technology – Grade 3**

### **Outcome 4**

Students will identify: patterns of the Earth, Sun, Moon, and stars; how planets in the solar system are alike and different; how technology affects our lives.

### **Essential Questions:**

- What patterns do the Earth, Sun, Moon and stars show?
- How are the planets in the solar system alike and different?
- How does technology affect our lives?

### **Enduring Understandings:**

- Earth's revolution around the Sun and rotation on a tilted axis cause the patterns of day, night, shadow, seasons, and the movement of stars across the sky. Light from the Sun and the revolution of the Moon around Earth cause the patterns of the phases of the Moon and the eclipse.
- The planets in the solar system all rotate on an axis and revolve around the Sun in orbits. The planets are different sizes, different distances from the Sun, and take different amounts of time to rotate and revolve. Each planet in the solar system has special features that make it different from the other planets.



• Technology applies the knowledge gained from science to solve problems and improve our lives. Technology helps us to get energy to do work and to develop cleaner energy sources.

### **Outcome Assessment: Select one**

- Performance Assessment Model a solar system.
- Full Inquiry Assessment How does the speed of a meteorite affect the crater it makes?

### <u>Life Science – Grade 4</u>

#### Outcome 1

Students will identify: classifications of living things; features that help plants make their own food and reproduce; how organisms interact with each other and their environments; how changes in ecosystems affect our world; how the body's smallest and largest parts work together.

### **Essential Questions:**

- What are some ways to classify living things?
- What features help plants make their own food and reproduce?
- How do organisms interact with each other and with their environment?
- How do changes in ecosystems affect our world?
- How do the body's smallest and largest parts work together?

### **Enduring Understandings:**

- Cells make up all living things. Some of the cells have special jobs. Plants and animals are sorted by their characteristics. Living things have adapted to survive in their environments.
- Plants make their own food. The parts of a plant work together to meet the plant's needs. Plants reproduce in different ways.
- Ecosystems have living and nonliving parts. The flow of energy and matter through one ecosystem is a complex path.
- Living things depend on one another and upon their environment. Change affects living and nonliving things in an ecosystem.
- Cells in the human body are organized into structures that form systems that work together. The systems have different jobs. Parts of the human body help fight disease.

### **Outcome Assessment: Select one**

- Performance Assessment How seeds travel.
- Full Inquiry Experiment Do mealworms prefer damp or dry places?

### Earth Science - Grade 4

### Outcome 2

Students will identify: how Earth's water affects weather; how storms affect Earth's air, water, land, and living things; how rocks tell us about Earth's past, present, and future; how Earth's surface is shaped and reshaped; how living things always have the resources the need.

#### **Essential Questions:**

- How does the water cycle affect Earth's weather?
- How do violent storms affect both living and nonliving things on Earth?
- What do rocks tell us about how the Earth was formed and how it continues to change?
- What changes Earth's surface?
- How can living things always have the resources they need?

#### **Enduring Understandings:**

- The water cycle changes salty ocean water into the fresh water we need for our daily activity.
- Weather depends on the way air masses move and interact. Scientists use many measurements to predict the weather.
- A hurricane is formed by bands of strong thunderstorms swirling around an area of calm. Tornadoes are violent, swirling winds that can appear with little warning.



- Rocks are classified by how they formed. Fossils in rock are clues to Earth's past.
- Erosion and deposition of weathered rock change landforms over long periods of time. Volcanoes, earthquakes, and other natural forces change Earth's surface quickly.
- Natural resources are both living and nonliving. Some natural resources are renewable and some are not. Some sources of energy are renewable and some are not.

#### **Outcome Assessment: Select one**

- Performance Assessment Make a wind vane.
- Full Inquiry Experiment What affects how rain erodes soil?

### Physical Science - Grade 4

#### Outcome 3

Students will identify: how matter can be compared, measured, and combined; how heat energy moves from one object to another; some ways that energy can be changed from one type to another; how sound and light travel; what causes motion and how does it affect us; how simple machines make work easier.

### **Essential Questions:**

- How can matter be compared, measured, and combined?
- How does heat energy move from one object to another?
- What are some ways that energy can be changed from one type to another?
- How do sound and light travel?
- What causes motion and how does it affect us?
- How do simple machines make work easier?

### **Enduring Understandings:**

- We use tools to measure the mass and volume of matter. Observations and measurements help us to compare matter. Physical and chemical changes can happen when matter is combined.
- Heat energy can move from one object to another by conduction. Heat moves through liquids and gases in a pattern called convection. Energy from the Sun comes to the Earth by radiation.
- Electric charges can move through wire as electric current. Electric current can produce magnetic fields.
- Sound travels in waves through solids, liquids, and gases. Light travels as electromagnetic waves.
- Forces start objects moving, speed them up, slow them down, or stop them. Changes in motion require energy.
- Simple machines change the direction a force is applied. Simple machines can also change the amount of force you need to apply.

### **Outcome Assessment: Select one**

- Performance Assessment Height and potential energy.
- Full Inquiry Experiment How is motion affected by mass?



### Space and Technology - Grade 4

#### Outcome 4

Students will identify: how cycles on Earth are affected by the Sun and Moon; how Earth is different from the other parts of the solar system; how technology affect the way we live.

### **Essential Questions:**

- How are cycles on Earth affected by the Sun and the Moon?
- How is Earth different from the other parts of the solar system?
- How has technology changed the way of life?

### **Enduring Understandings:**

- Earth's movement around the Sun causes the seasons. The shape of the Moon appears to change as it revolves around the Earth. Eclipses occur as a result of the Moon revolving around the Earth. Earth's rotation is the reason groups of stars seem to move across the sky.
- The part of the universe known as the solar system is made up of the Sun, planets, moons, other objects, and mostly empty space. Each planet in the solar system rotates on its axis and revolves around the Sun. Some planets have similar characteristics.
- Advances in technology make our work easier and give us products that keep us safe and comfortable. Faster systems of transportation and communication are results of technology.

#### **Outcome Assessment: Select one**

- Performance Assessment How technology helps scientists.
- Full Inquiry Assessment How does payload affect the distance a model rocket can travel?

### Course: Grade 5 Science

### Life Science – Grade 5

### Outcome1

Students will identify: how living things are classified; what cells have to do with our lives; how your body systems keep you alive; how plants stay alive and reproduce; how parts of an ecosystem interact; and how changes in habitats affect living things.

### **Essential Questions**

- How are living things classified?
- What do cells have to do with our lives?
- How do the systems in your body keep you alive?
- How do plants stay alive and replace offspring?
- How do the parts of an ecosystem interact?
- How do changes in habitats affect living things?

### **Enduring Understandings**

- Living things are classified by their structure. Vertebrates are animals that have backbones. Invertebrates are animals that have no backbones. Other living things include plants, fungi, protists, eubacteria, and archaebacteria.
- Cells are the basic units of living things. The body has different kinds of cells. Organs, which are made up of many cells, work together to carry out major life functions.
- The circulatory system moves materials around the body. The respiratory system carries gases between the outside air and the blood. The digestive system breaks down food into materials that cells can use. The urinary system filters waste out of the blood and removes it from the body.
- Photosynthesis takes place in chloroplasts in plant cells. Stems hold other plant parts in place and
  carry sugar, water, and minerals through the plants. Roots anchor a plant, absorb water from the soil
  and may store food. Fertilization and seed formation take place in flowers. Different plants grow in
  different ways, depending on their DNA and on the environment.
- Living things in an ecosystem can affect each other. Organisms can affect and be affected by nonliving parts of the ecosystem. Conditions in an ecosystem and relationships among its parts keep an ecosystem balanced.
- If conditions change, organisms may or may not be able to survive in the new conditions. Some changes, such as adaptations, can help living things survive.

#### **Outcome Assessment: Select one**

- Performance Assessment Choose a familiar plant and illustrate or use pictures from magazines the show germination, seedlings, growth, and pollination.
- Full Inquiry Experiment How does salt affect the hatching of brine shrimp?

#### Earth Science - Grade 5

### Outcome 2

Students will identify: how water moves through the environment; why weather changes; the process that change the Earth's surface; and the importance of conserving Earth's resources.

### **Essential Questions:**

- How does water move through the environment?
- Why does the weather change?
- What kinds of forces change Earth's surface?
- Why is it important to conserve Earth's resources?



### **Enduring Understandings:**

- Water changes from one form to another as it moves through the environment in the water cycle. Water's forms include liquid water, water vapor, and snow and ice. Steps of the water cycle include evaporation, condensation, precipitation, and runoff.
- Weather changes when masses of air in different places have different temperatures and other conditions. When air masses with different conditions move across Earth, they can cause weather changes in places they pass.
- The movement of Earth's plates can cause big changes on its surface, including earthquakes volcanic eruptions, and mountain formation. Weathering and erosion change Earth's surface more gradually.
- Nonrenewable resources cannot be replaced if they are used up. Some produce dangerous wastes. Even renewable resources have disadvantages. Some are expensive to use or are not efficient. Others, such as geothermal energy and moving water, can only be used in certain places.

#### **Outcome Assessment: Select one**

- Performance Assessment draw a water cycle.
- Full Inquiry Experiment how does temperature affect the growth of crystals?

### Physical Science – Grade 5

#### Outcome 3

Students will identify: what are the properties of matter; how atoms combine; how phase changes occur; and what are mixtures and solutions.

### **Essential Questions:**

- What makes up everything around us?
- How do you use chemistry every day?
- How are forces and motion part of your everyday life?
- How many types of energy do you use every day?
- What is electrical current and how does it work?

#### **Enduring Understandings:**

- All things around us are made up of a few kinds of matter called elements. Most elements combine with others to form other kinds of matter, called compounds. Objects are solids, liquids, or gases depending on the arrangement and movements of their atoms or molecules.
- Matter undergoes physical changes and chemical changes. Chemical and physical properties can be
  used to produce new materials or separate substances. Chemists have invented new materials we use
  all the time, such as nylon and concrete.
- Objects move in predictable ways that are described by the laws of motion. Machines combine force and motion to make our work easier.
- One type of energy can be transformed into another type of energy. Different types of energy travel in waves. Sometimes, but not always, you can see, hear, or feel the results of energy on the move.
- The flow of charges through a material produces an electric current. Magnets can be used to increase the strength of the current in a circuit.

#### **Outcome Assessment: Select one**

- Performance Assessment On a globe or map of the Earth, show where plate boundaries are and how plates move. Indicate where changes on Earth's surface take place and where resources are located.
- Full Inquiry Experiment Can you change the poles of an electromagnet?



### Space & Technology - Grade 5

#### Outcome 4

Students will identify: the history of astronomy; the characteristics of a star; and how stars are grouped together.

### **Essential Questions:**

- How has the study of stars changed through time?
- What are the effects of Earth's distance from the Sun?
- How does technology affect our lives?

### **Enduring Understandings:**

- People have learned about our planet by observing objects in the sky.
- New technology helps us learn about galaxies, stars, gases, asteroids, comets, planets.
- Life is possible on Earth because of its position in the solar system. Effects of Earth's position include the length of a year, day and night, temperature, seasons, and climate.
- Technology affects the way we travel, communicate, produce goods, explore space, and advance knowledge. Technology can help solve problems, but it can also cause new problems.

#### **Outcome Assessment 4: Select one**

- Performance Assessment make a model of a planet's orbit
- Full Inquiry Experiment Which writing tool might work best in space?

• As of Wednesday (1/15/06) the education committee had not moved any of the Metro bills out of committee. Senator Raikes appears determined to move 1024 out of committee. It does not appear that he has consensus. The latest discussion points indicate that Senator Raikes is trying to move the major part of LB 129 into this legislation. By doing so, he is further complicating this issue.

#### **Dates and Reminders**

• The Legislature will be in recess March 20, 31 and April 7. The last day of the session is April 12th.

- LB 1024 This is Senator Raikes bill on learning communities. It is a massive document and will require time to review. It appears to have all of the elements we expected in that it applies to Douglas and Sarpy school districts, forms a new board called Learning Community Boards, sets a common levy, a capital fund levy, focus schools and programs, and reorganization criteria in the future.
- LB 1107 and 1148 allow students to self-administer medications for diabetes and asthma. Our current policy is in line with these bills.
- LB 1167 Senator Redfield's bill has a high school and feeders in a district and sets the size at a minimum of 4,000 students.
- LB 1208 is the result of the interim work on Distance Education. This bill lays out an infrastructure for school districts to upgrade technology capability and access academic offerings.
- LB 1262 is Senator Brashear's proposal. The Senator has indicated on numerous occasions that this is a shell bill that could represent a compromise.

### **Carryover Legislation we are tracking:**

• LB 129 – is a comprehensive school finance bill. It is likely that part or this entire bill may become a part of LB 1024. Senator Raikes has indicated that this bill is a priority. He has strong feelings that this legislation needs to be considered. This bill is currently held in committee.

- LB 579 is a technical clean-up bill that repeals the 1981 law and has language that changes items such as transportation, option enrollment, and items dealing with early childhood.
- LB 627 is a bill that will require school districts to adopt a policy on bullying. This bill is not yet out of committee.
