Roll call was taken and all members were present.

John Crawford provided the explanation for 1) the nature of the proposed high school, 2) the necessity for the proposed high school project, 3) the reasons for selecting the proposed location of the high school, and 4) the quantity of land needed to complete the high school project.

BACKGROUND:	The District's liability insurance does not extend beyond the US (and its territories) and Canada.				
	Prior to 9-11-01, some foreign language teachers worked with travel agencies during the summer and promoted foreign travel by students. This travel was not sponsored by the school district, however, many parents thought it was because the travel was organized and promoted by the teachers in their classrooms. In some instances, the funds for the trips were handled through the student activities funds at the buildings.				
	As a result of the events of 9-11-01, many of the travel agencies cancelled their scheduled trips to foreign countries and refused to refund the money to the students. Some of the students (actually, the parents) contacted the school with a request that the school refund the moneys because it was a "school-sponsored trip." The administration took the position that the foreign travel was not sponsored by the school and denied the requests for the refunds.				
	Subsequently, the administration directed that the line of separation between the activities sponsored by the schools and the activities sponsored by private organizations (in particular travel agencies working with teachers), be made clear. The substance of that directive is contained in the proposed Policy 3921 and Rule 3921.1.				
	In recent months, it has become apparent that the administrative directives noted above have begun to erode again. Therefore, a "reminder" has been sent to the buildings and the directive has been reduced to writing in the form of a Policy and Rule for consideration by the Board.

Pursuant to Policy 3921, the District does not sponsor nor endorse any student travel outside of the United States or Canada. In furtherance of such policy, the following rules are established:

- A. If a private (non-school-related) organization desires to arrange private foreign travel, the organizational meetings for such travel should be held at non-school locations. However, if the private organization submits a request to use District facilities for such purposes, the request shall comply with the District's facility use policies and procedures and the organization shall be treated as a for-profit organization. Further, within the first ten minutes and again during the last ten minutes of any meeting held on school property, the individual in charge of such meeting shall inform those in attendance that the travel is in no way sponsored or endorsed by the Millard Public Schools.
- B. No money for such private travel shall be deposited into school District funds nor shall any expenses for such private travel be paid out of District funds.
- C. No fundraising activities shall be conducted on school grounds or as part of any school activity.
- D. No teacher, administrator, or other employee of the District shall, in his/her capacity as a District employee, promote private travel plans in his/her classroom, at school activities, or during any other time when the teacher is on duty with the District. Notwithstanding the foregoing, a teacher may, during the summer months when he/she is not under contract with the District, provide services to a private organization conducting foreign travel tours.

#### Curriculum, Instruction, and Assessment

#### **Student Fees**

The District may require and collect fees or other funds from or on behalf of students or require students to furnish or provide materials, supplies, equipment, or attire consistent with the Public Elementary and Secondary Student Fee Authorization Act.

The Superintendent (or designee) shall promulgate the rules and/or procedures necessary for implementation of this policy. For purposes of Neb. Rev. Stat. §79-2,133 and §79-2,134, such rules and/or procedures, when adopted or approved, shall be incorporated in their entirety into this policy by this reference.

On or before August 1, 2002, and annually thereafter, the school board shall hold a public hearing at a regular or special meeting of the board on a proposed student fee policy, following a review of the amount of money collected from students pursuant to, and the use of waivers provided in, the student fee policy for the prior school year. The student fee policy shall be adopted by a majority vote of the school board and shall be published in the student handbook. The board shall provide a copy of the student handbook to every student at no cost to the student.

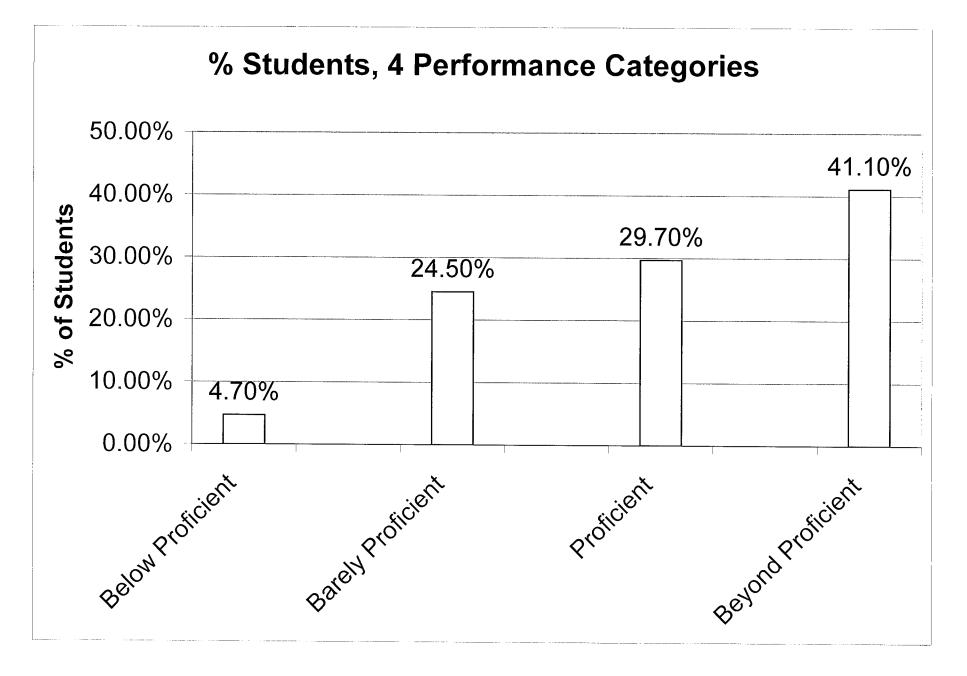

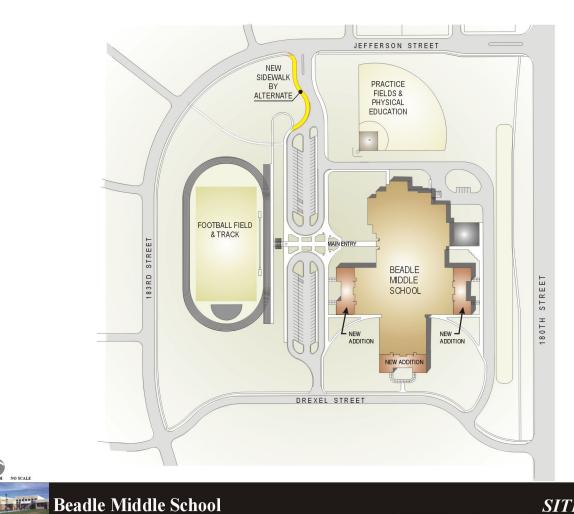

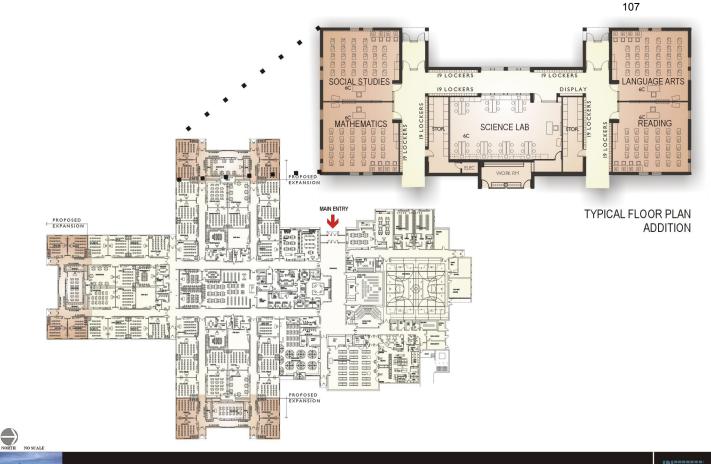

#### **Issues and Happening**

What a session. This one will go down in history. At the time of this writing we are preparing for the final vote on LB 1024. As amended LB 1024 would:

- create a learning community among all school districts in Douglas and Sarpy counties;
- divide OPS into three separate school districts, based on existing attendance areas with two to three high schools in each new district;
- provide that the learning community be governed by a coordinating council made up of school board members from the member districts;
- form an integration task force within the learning community to develop plans for integrating all metro-area schools;
- allow the learning community to assess and collect a property tax levy of up to \$1.02 for school district operating expenses, 1 cent for the learning community budget and 2 cents for the special building funds of member districts;
- maintain existing school district boundaries;
- allow for the creation of focus schools and programs within the learning community;
- permit students to attend any of the schools within the learning community with capacity to accept students and establish priorities for acceptance at schools exceeding capacity;
- make changes to the state aid formula to provide more resources for students living in poverty, students with limited English language proficiency, small school districts with declining enrollments, and focus schools and programs;
- require the appointment of a coordinator to focus on high needs children.

Maintenance Department recently reported significant roof leaks over the north section of the Bryan roof. The leaks became severe during the melting process immediately following the snowstorm of March 20 and 21. The District's roof maintenance contractor (Rawson & Sons Roofing) was dispatched to make several temporary repairs, and to take a core sample of the existing roof. Rawson has advised that the temporary repairs are unlikely to provide weather-tight conditions through the 06-07 school year. The roof core indicates that a second roof was installed over the original roof at some point in the past. Based on these findings, we have engaged RSI and are pursuing estimates, design and bidding, in an attempt to replace this section of approximately 12,000 SF during summer of 2006.

# Quarterly Review January – March 2006

# I. Accomplishments

# MAINTENANCE HIGHLIGHTS

- Several projects were completed by the Mechanical Department during the quarter. Below are some of the highlights:
  - Ackerman replaced hot water heater and re-piped
  - Aldrich repaired intercom repeatedly throughout the quarter
  - Black Elk upgraded select heat pump controllers
  - Ezra repaired HVAC pneumatic control compressor; repaired numerous pneumatic controls; cleaned air handler and installed higher grade filters
  - o Neihardt installed and insulated kitchen hot water storage tank
  - Reeder installed new filters as a pilot program and as a result of the high dust levels due to construction in the surrounding areas
  - Andersen replaced domestic hot water tank; improved integrity of HVAC ductwork by sealing gaps.
  - Beadle coordinated the installation of replacement controls by Honeywell (warranty)
  - o Central Middle repaired chiller
  - Kiewit replaced defective heat pump in 6<sup>th</sup> grade area
  - Russell Balcon balanced a section of Russell to improve the make-up airflow due to air quality complaints.
  - South High Prairie Mechanical and Control Masters installed new ductwork and controls for ensuring penthouse units will not freeze up; considerable repairs were made to various VAV boxes to correct their operation; work began to convert AHU #1 and #2 to DDC controls
  - West High repairs were made to HVAC equipment in the pool area and converted to DDC controls; repaired supply air duct
  - North High located and repaired as needed exhaust fans throughout the building
  - DSAC coordinated the installation of the new fire alarm panel and associated hardware; replaced gas hot water heater with electric and installed a forced air blower into exhaust duct to eliminate fumes





# I. Accomplishments (continued)

- Indoor Air Quality issues were reported and investigated at the following locations:
  - o Russell Middle
  - o Ezra
  - o Central Middle
  - o West High
  - o Reeder
- In the pool locker room shower area at West High, the paint was stripped off the walls and ceramic tile was installed by our Carpentry Department. This was done due to the paint continually peeling off the wall and making it hard to sanitize.
- Steve Laire met with vendors to secure pricing on the replacement of Russell's cooling tower and Bryan's cooling tower. Scheduling is currently taking place.
- Henry Rohwer met with MUD on 3/17 to review the water meters in the athletic areas of South High and Buell.
- District wide, cooling towers and chillers are being prepared for the cooling season.
- A new door card reader access system is being installed at North High. This system is similar to the one installed at DSAC, and will be used to better control door access during the week and weekends, as well as increase security by eliminating the need for exterior keys. The system is being installed by Siemens and will be functional in April.
- Painting projects occurred throughout the District during the quarter. Some of the larger projects were completed at Abbott, Aldrich, Bryan, Cody, Harvey Oaks, Norris, Reeder, Sandoz and all three High Schools.
- The District Electrician replaced all the outlets with GFI outlets in the Family Consumer Science room at Andersen for safety reasons.
- The Carpentry Department completed several projects throughout the District including:
  - o Lunch room table repairs
  - o Bleacher repairs
  - o Door repairs
  - Support Service Plan room
  - o Mechanical Department work benches
- The District's vehicle mechanic made several repairs to snow blowers, plow trucks and sanders during the winter months. As well as the normal preventative and corrective maintenance on all Maintenance and Grounds vehicles and equipment.

# **GROUNDS HIGHLIGHTS**

- The Grounds Crew worked on the following during the months of January, February and March:
  - Completed re-mulching
  - Wood chipping playgrounds
  - Tree and shrub pruning
- Snow removal operations took place during the week of March 20<sup>th</sup> throughout the District.
- The Athletic Crew removed snow from Buell in order for soccer games to be played on the field after the March snow.
- Irrigation system charging began at the end of March and will continue into early April until all systems are up and operational.
- The Grounds Department re-graded and re-seeded the hill east of Beadle Middle due to erosion problems.
- The Grounds Crews performed several playground repairs throughout the District.
- At Harvey Oaks, landscape fabric was installed and the school re-mulched.
- Traffic signs were straightened throughout the District.

# CUSTODIAL HIGHLIGHTS

- Diane Moore and Ian Leader continued to interview and recommend new hires for the Custodial Department sub pool. In addition, Diane, Ian, Jim Cerveny and Gloria Lincoln interviewed and filled open custodial positions throughout the quarter.
- Preparations were made for Spring Break project cleaning at all buildings. An update of what was accomplished will be in next quarters report.

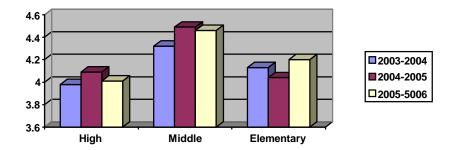

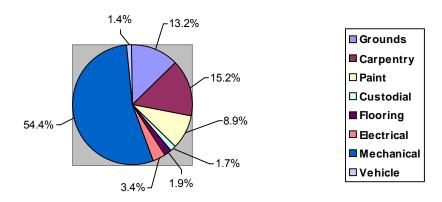

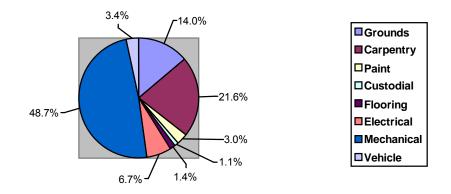




#### Percentage of Open Work Orders by Department

A summary of Millard Food Service's financial performance, participation and operational highlights follows. If you need any further detail regarding our department, please ask.

#### **Financial Performance**

**During the 3<sup>rd</sup> Quarter,** continued strong program participation led to a quarterly gross return of \$216k. The department transferred \$138k of this return back to the buildings for a net return of \$78k. This strong performance

overcame two snow days and an additional seven service days lost at the high schools due to testing. Expenditures as a whole remained consistent. District labor was higher due to two more payroll days than service days, but ARAMARK direct expenses were lower because of reduced commodity and replacement costs. The 3<sup>rd</sup> quarter of SY2005 had fewer service days. The costs associated with these reduced sales were also higher.

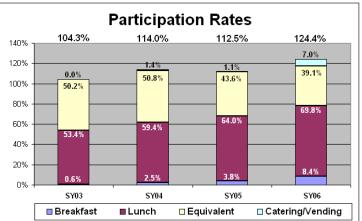
**Year to date**, Millard Food Service has shown a gross return of \$470k. After building allocations, the department's net return is \$147k. A detailed operating report is attached for your review (*attachment A*).

**Looking forward,** we are forecasting a gross return of \$108k and a net return of \$16k during the  $4^{th}$  quarter. This would bring projected final gross return to \$578k and our projected final net return to \$163k.

#### **Meals and Participation**

The graph below shows the District-wide participation growth within our department. We are very proud of our gains

in the qualifying breakfast and lunch programs. This has always been our focus. Increased participation leads to more government subsidies and a higher commodity allotment. Decreased participation in equivalent meals is reduced amounts of a la carte and snack sales. The last two years have seen a strong displacement of student purchasing preferences from a la carte to complete meals. Nonexistent in SY03, our catering and vending programs have grown considerably this year. Both are expected to show continued growth next year. The financial and participation dashboards are included at the end of this report.





#### New Programs

Since our last report, Millard Food Service has opened new services and programs:

- 1. Starting in January, breakfast programs were opened at the remaining 12 elementaries and all 3 high schools. These new programs added 14,701 new breakfast meals, nearly 20% of which were served to free or reduced-priced students. We are especially proud of our North High staff which is averaging over 100 a day!
- 2. We know that our lunch service can be difficult for adults at the elementary level. In order to achieve our high rates of student participation, our offerings have to be "kid-friendly" and we know that adults and children have different meal preferences. Our management team felt that our elementary kitchen staffs were ready for the added responsibility of new adult menued entrées. We have started with an attractive collection of salads that were designed by our catering manager, Chef Billy Ray. A menu of these salads is attached (*attachment B*). Under the direction and organization of Chef Ray, the program successfully piloted at Reeder with others following. Presently, the service is only available to staff members and we are averaging between 5 and 10 salads a day per building. We will open the service up to our visiting parents when the building-specific ordering procedures are developed. Once completely open to all, we anticipate a minimum average of 10 per building. The selection of salads will continue to grow along with an addition of sandwiches and soups offered in the future. We are forecasting an additional \$150k in revenue from this program next year.
- 3. We have always felt a strong responsibility to be part of the educational process. We understand our role of providing nutritious meals that fuel the body and how that helps the mind become ready to learn. But when we can become a direct resource of curriculum, our role becomes even more special. Such is the situation at North High and opening at South High in April. In both buildings, Millard Food Service has taken complete control of the snack vending machines. Outside full-service vendors were removed and new, District-owned, vending machines were purchased with ARAMARK's capital investment money. Special education classes work directly with our department in the management of the vending programs. All procedures were written with the student's capabilities in mind. When necessary, picture "pull-sheets" are used. Simple inventory organization and other business principals are experienced. As the student's proficiency develops, our involvement in their IEP increases. Financially, it has been a great success. Year to date, our snack vending sales at North High has been \$31.6k with a \$17.4k return. At South High, our year to date commissions from the outside vendor has only been \$2.4k. There's little doubt this program will be offered to West High and all Middle Schools next year.

#### 2006-07 Commodities

March is the time of year that we make our commitments for next year's commodities. When ARAMARK first started managing the department our allotment was \$275k of donated products. A school's allotment is based upon \$.175 for each qualifying lunch served the previous year. I'm pleased to report that after two years of driving participation in the lunch program we have increased next year's allotment to over \$425k. We have directly contracted with the USDA for \$250k of the allotment. This eliminates processing and warehouse charges levied by the State of NE. Again, when ARAMARK first started, the processing, handling and warehousing of commodities reached \$265k. Because of the new arrangements, we have been able to lower these charges to an anticipated \$175k for SY07.

- USDA committed items: ground beef, beef patties, ham, mozzarella block cheese, turkey breast and canned/frozen fruits and vegetables.
- NE processed committed items: chicken patties (spicy and regular), elementary chicken tenders, chicken fajita meat, chicken-fried steaks, beef crumbles (pre-cooked ground beef for our "former satellite elementaries") and beef meatballs.

#### **Legislative Watch**

The school foodservice reform movement, which has been sweeping through states and local school districts, has now reached the nation's capital. Recently, Senator Tom Harkin (D-IA) introduced the *Child Nutrition Promotion and School Lunch Protection Act*. If passed, the outcome of the bill could cause sweeping changes that will go beyond what our own Local Wellness Policy prohibits. The bill calls on the U.S. Department of Agriculture (USDA) to update its decades-old nutrition standards for drinks and snack foods sold in cafeterias alongside the regular school meals and to apply those standards everywhere on school grounds, including vending machines, school stores and fund-raisers. Of particular attention to our District are the probable removal of deep-fat fried foods and the complete elimination of

carbonated soda and isotonic beverages. The Act has earned the endorsement of the Center for Science in the Public Interest, the national Parent Teacher Association, the School Nutrition Association and the 85 member organizations of the National Alliance for Nutrition and Activity. The proposed bill is attached (*attachment C*).

#### SY07 Budget

We are also in the process of developing next year's budget. We use the *Food Away from Home Consumer Price Index* in helping us shape our forecasted costs. All indications point to a 3.5% increase in costs – mostly because of fuel prices. This equates to an average cost increase of \$.075 per meal. We are also conscious of the increasing participation in our web-based payment system, mylunchmoney.com, and the increasing amount of merchant fees associated with the service. Of course, it should be expected that we continue to grow our participation and we anticipate such growth. But, the additional returns from participation growth are thought to offset the cost of an additional supervisor in the office as well as increased building allocations. Although the formal survey of area districts will not be completed until May, informal and grapevine chatter suggest most metro-area schools are contemplating a \$.10 increase in meal prices for next year. As with last year, I will work multiple scenarios for your consideration.

# SEC. 102. CHILD NUTRITION PROMOTION AND SCHOOL LUNCH PROTECTION.

Section 10 of the Child Nutrition Act of 1966 (42 U.S.C. 1779) is amended--

(1) by striking the section heading and all that follows through `(a) The Secretary' and inserting the following:

SEC. 10. REGULATIONS.

`(a) In General- The Secretary'; and

(2) by striking subsections (b) and (c) and inserting the following:

`(b) Food of Minimal Nutritional Value-

`(1) PROPOSED REGULATIONS-

`(A) IN GENERAL- Not later than 180 days after the date of enactment of this paragraph, the Secretary shall promulgate proposed regulations--

`(i) to revise the definition of `food of minimal nutritional value' that is used to carry out this Act and the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.); and

`(ii) to rename the term `food of poor nutritional value'.

'(B) REQUIREMENTS- In revising the definition, the Secretary shall--

`(i) cover all foods made available--

`(I) outside the school meal programs;

`(II) on the school campus; and

`(III) at any time during the school day;

`(ii) shall consider both the positive and negative contributions of nutrients, ingredients, and foods (including calories, portion size, saturated fat, trans fat, sodium, and added sugars) to the diets of children;

`(iii) consider evidence concerning the relationship between consumption of certain nutrients, ingredients, and foods to both preventing and promoting the development of overweight, obesity, and other chronic illnesses; and

`(iv) consider recommendations made by authoritative scientific organizations concerning appropriate nutritional standards for foods sold outside of the reimbursable meal programs in schools.

#### `(2) IMPLEMENTATION-

'(A) EFFECTIVE DATE-

`(i) IN GENERAL- Except as provided in clause (ii), the proposed regulations shall take effect at the beginning of the school year following the date on which the regulations are finalized.

`(ii) EXCEPTION- If the regulations are finalized on a date that is not more than 60 days before the beginning of the school year, the proposed regulations shall take effect at the beginning of the following school year.

(B) FAILURE TO PROMULGATE- If, on the date that is 1 year after the date of enactment of this paragraph, the Secretary has not promulgated final regulations, the proposed regulations shall be considered to be final regulations.'

# Millard Public Schools Investment of Funds March 31, 2006

# Nebraska School District Liquid Asset Fund

The Millard Public Schools utilizes the Nebraska School District Liquid Asset Fund (referred to as either NSDLAF or CADRE, the financial services firm which manages the fund) for day-to-day investing. NSDLAF was established in 1988. The fund is offered exclusively to Nebraska school districts, educational service units, and technical community colleges. The fund's objective is to allow school districts to pool their dollars for investment. The fund invests in items permitted by Nebraska law (i.e. repurchase agreements, U.S. Government Agency Obligations, U.S. Treasury Bills and Certificates of Deposit).

MPS maintains two liquid accounts that can be accessed daily. The General Fund, Food Service Fund, Administrative Activity Fund, Special Building Fund, Bond Fund, Depreciation Fund, Construction Fund and Employee Benefit Fund utilize one account. This account is used throughout the month as taxes, state aid, etc. are received and as bills or payroll are paid. The other account is utilized by the various middle schools. As of March 31, 2006, the 7-day current yield for these accounts was 4.21%. MPS also utilizes long term fixed investments (examples: 30, 60, 90 day US Government Securities, Certificates of Deposits, etc). The current rate of return depends on the term, with the district currently earning 3.81% to 4.50%.

# Sweep Account for General Checking Account

Each day, any balance remaining in the District's main checking account above the level necessary to avoid service charges is invested in either U.S. Government agency backed repurchase agreements (amounts under \$25,000) or commercial paper notes (amounts over \$25,000). The interest rate for the sweep account is currently 3.65%.

# Bond Fund Trust Account at First National Bank of Omaha

Taxes and other revenues received for the repayment of bond principal and interest are invested through the trust department at First National Bank of Omaha. The funds are invested in U.S. Treasury Bills, individual U.S. Government Agency backed securities, or a money market account which invests in U.S. Government backed agency securities, based on the funds available, the time line until the next debt service payment, and the available yields. The trust account balance as of March 31, 2006 was \$3,808,668.32.
