Board of Education Minutes September 2, 2008 Page 2

Jean Stothert summarized the committee of the whole meeting on August 18, 2008. The topics discussed included an update on the 2008-2009 budget, and discussion on the legislative agenda for 2009.

#### Superintendent's Comments:

- 1. The first two weeks of school have been completed. School enrollment is down from what was projected, but the official report is done on the last Friday of September to report to the Nebraska Department of Education.
- 2. The committee meeting for next Monday will have a presentation on the 40 assets, and will be discussing the achievement gap. If there is time remaining Ken Fossen and Jon Lopez will talk about the GPS tracking system.
- 3. Dr. Lutz welcomed the student representatives to the Board.

#### **Board Comments:**

Mike Pate welcomed the student representatives and asked them to participate freely in the discussions at the board meetings.

Mr. Pate said he attended the Nebraska Association of School Board's workshop for candidates for the Learning Community. The Learning Community candidates went from table to table to visit school board members, and to answer questions from the board members. Mr. Pate said he is now more concerned than he ever was after visiting with some of the candidates. He indicated that very few knew what they would be doing. Mr. Pate continued by saying no one could say how this will improve student achievement. He said he doesn't see how the Learning Community Coordinating Council will be able to anything for student achievement after listening to the various candidates. He was concerned that they may want more power than what is originally given to them as they go along.

Linda Poole agreed with the comments made by Mr. Pate. She said she was concerned, because one candidate she talked with said "the local school boards are going to work for me," and she thought they may want to extend their arms and get into areas where they are not suppose to.

Dave Anderson echoed comments made by Mr. Pate and Mrs. Poole. Mr. Anderson said for the people who would be voting for the Learning Community candidates that Millard is in District 4. He encouraged everyone to please look at who they are voting for, and do some research on the candidates so they know why the candidates are running of the position. Mr. Anderson repeated that you can only vote for one person, so to look at the people who are running.

Mr. Anderson did appreciate talking with the candidates about how much they understand the Learning Community. He said some who are running make him nervous, because hey haven't done their research. There are some that are qualified. There are several who have an education background, and have good intentions. He asked people to get involved, because things could change significantly.

Mr. Anderson welcomed the student representatives and told them the board does value their input.

Mr. Anderson thanked all of the buildings for a good start of school. He said he had the opportunity to tour Upchurch Elementary. Mrs. Anglemyer spent an hour to show him around the building. He said the design and the way it is laid out is very well done. The building also came in on budget.



The members of the Board of Education met as a Committee of the Whole on Monday, September 8, 2008 at 7:00 p.m. at the Don Stroh Administration Center, 5606 South 147th Street. The agenda included presentations on the 40 Developmental Assets, Achievement Gap, Edulog Program demonstration, and 2008-2009 Budget.

ABSENT: Mike Kennedy

Kraig Lofquist explained the inclusion of the 40 Developmental Assets came out of the Strategic Plan Strategy 7. The Developmental Assets are concrete, common sense, positive experiences and qualities essential to raising successful young people. The assets have the power during critical elementary as well as adolescent years to influence choices young people make to help them become caring and responsible adults.

The assets are research based, and the research shows the more assets a student has, the better they will do in school and in life. These assets promote positive behaviors and also protect young people by increasing their resiliency.

The students take the survey in grades 7, 9, and 11. There are four internal and four external developmental assets. The internal assets include commitment to learning, positive values, social competencies, and positive identity; and the external assets are support, empowerment, boundaries and expectations, and construction use of time. The student average is 19 assets

Jon Lopez summarized his achievement report by saying Millard students aggregately score at or above the state and national averages on assessments given for AYP, nationally-normed tests, and aptitude tests such as the ACT or SAT exams. Although a gap in achievement exists in a number of areas between sub-groups, the gap is often relatively small, and in many cases does not have a consistent trend line of underachievement from one year to the next for most sub-groups. A small sample size, in some sub-groups significantly skew the data in either the positive or the negative direction. In a number of cases, students in sub-groups who are scoring lower than their Millard peers are scoring as well as or better than the general population of the state or the nationally-normed sample group of students.

Mr. Lopez said the key for Millard is to keep a rigorous complete assessment system in reading, math and writing.

In the areas of concern the Educational Services division makes every effort to identify the students and provide additional help in their particular subject area.

Jon Lopez provided a brief review of how the Edulog program works as a transportation manager, and how it will help in being able to calculate enrollment projections, and boundary planning.

Ken Fossen reported to the board he received notification from OPPD that electrical rates are expected to go up 17%, so this would be an additional expenditure of \$400,000 in the budget. To avoid the one-cent increase of the tax levy three additional options were provided to the board to consider. First, was an additional reduction of the cash reserve by \$1.3 million, second, was a reduction in expenditures by \$1.3 million, and the third, an additional reduction in the Employee Benefits Fund by \$1.3 million.

Dr. Lutz recommended watching the budget month by month, and will look for expenditures that can be reduced before additional funds are borrowed from the Employees Benefit Fund. The board will be provided a financial report monthly.

Board members discussed the pros and cons of each of the three options, and agreed not to reduce the cash reserve anymore than it has been, and favored the combination of options two and three. The board still did not want any reductions that would affect the educational program for students. The board preferred monitoring the budget month by month, reducing expenditures, borrowing out of the Employees Benefit Fund if necessary, and not increase the tax levy by one-cent.

- The district has a process for periodic assessment of the multicultural education program. An annual status report is provided to the local board of education.

In designing the school day, the following considerations are to be met:

- I. The learning activities are to be carefully guided and supervised.
- II. Opportunities shall be provided so as to receive assistance from teachers outside of the regular school day.
- III. Instructional hour <u>for K-12</u> means a period of time, at least sixty (60) minutes, which is actually used for the instruction of students.

Instructional hour in a preschool program means a period of time, at least sixty (60) minutes, which is used for teaching in the following areas of children's growth and learning: social-emotional development; cognitive learning in the areas of language and literacy; mathematics, science and problem solving; creative arts; health and nutrition; and physical and motor development. Meal or snack time is a part of the program curriculum and provides opportunities for learning and social development, as well as nutrition, and therefore is included as part of the instructional time.

- IV. The instructional hours per full school day will be six (6) hours in the elementary schools and six and one half  $(6\frac{1}{2})$  hours in the secondary schools. An alteration of the school day shall be subject to the approval of the <u>office</u> <u>Office</u> of the Superintendent.
- V. Parents of students and the general public shall be informed of the reasons for the variations which may exist in the times designated for the beginning and ending of the school day.
- VI. High school students shall take a minimum of four (4) classes (two in block) each semester.
- VII. Early dismissal to facilitate student employment shall be limited to course-related work study and /or internship programs. Exceptions due to hardship may be granted by the building principal or their designee.

#### Remuneration and Reimbursement

8230.1

Reimbursements and remuneration to board members shall be made through the board treasurer in accordance with the following guidelines:

- 1. Each board member may attend one major convention per fiscal year; provided, however, that the board member has notified the board in a regular or special meeting of the intention to attend the meeting and the identification thereof. Attendance at any additional meetings or events for which the board member wishes to be reimbursed for expenses shall be approved by the board before the expenses are incurred.
- 2. Board members will receive \$50 per diem expense money prior to major trips. Receipts and an expense report will be filed at the conclusion of the trip with the District. Any unexpended expense money will be returned to the District.
- 3. Car rental expenses related to the board member's attendance at meetings will be reimbursed.
- 4. Board members will pay expenses for spouses or family members who might accompany him or her on a trip, if that expense would not have been otherwise incurred by the board member.
- 5. Lodging, registration, and reservations may be made through the Superintendent's secretary.
- 6. Board members will be reimbursed at the current rate established by the Nebraska Department of Administrative Services for use of his or her automobile while on board business and in accordance with rules and opinions of the Nebraska Accountability and Disclosure Commission. A mileage report will be submitted to the District for reimbursement.
- 7. Board members will be reimbursed for materials purchased, which are deemed necessary by the board for Board purposes, such as books and other publications. Those materials will become property of the District and will become part of the board library.
- 8. A filing cabinet will be delivered to each board member to use at home during his or her term. At the end of his or her term, the board member shall return the file cabinet to the District.
- 9. Office supplies will be obtained from the central office. A board member will not be reimbursed for the purchase of any supplies by that board member without prior approval of the board.
- 10. Actual and necessary expenses for long distance telephone calls and broadband internet access will be reimbursed when approved by the board. Installation and monthly charges for a broadband internet connection that is to be used exclusively for communication with constituents, internet access, and other board business will be reimbursable. Bills are to be submitted to the District.
- 11. A computer meeting the "district standard" shall be loaned to each requesting board member during his or her term of office to assist in fulfilling their responsibilities as a board member. Upon retiring from the board of Education, the board member will be offered the opportunity to purchase the loaned computer based on fair market value. Board members will also be offered the opportunity to purchase the computer based on fair market value should the computer be replaced during their term of office. Such sales must be approved by a two-thirds vote of the entire board.

#### **Internal Board Policies**

#### Remuneration and Reimbursement

8230.1

Reimbursements and remuneration to board members shall be made through the board treasurer in accordance with the following guidelines:

- 1. Each board member may attend one major convention per fiscal year; provided, however, that the board member has notified the board in a regular or special meeting of the intention to attend the meeting and the identification thereof. Attendance at any additional meetings or events for which the board member wishes to be reimbursed for expenses shall be approved by the board before the expenses are incurred.
- 2. Board members will receive \$50 per diem expense money prior to major trips. Receipts and an expense report will be filed at the conclusion of the trip with the District. Any unexpended expense money will be returned to the District.
- 3. Car rental expenses related to the board member's attendance at meetings will be reimbursed.
- 4. Board members will pay expenses for spouses or family members who might accompany him or her on a trip, if that expense would not have been otherwise incurred by the board member.
- 5. Lodging, registration, and reservations may be made through the Superintendent's secretary.
- 6. Board members will be reimbursed at the current rate established by the Nebraska Department of Administrative Services for use of his or her automobile while on board business and in accordance with rules and opinions of the Nebraska Accountability and Disclosure Commission. A mileage report will be submitted to the District for reimbursement.
- 7. Board members will be reimbursed for materials purchased, which are deemed necessary by the board for Board purposes, such as books and other publications. Those materials will become property of the District and will become part of the board library.
- 8. A filing cabinet will be delivered to each board member to use at home during his or her term. At the end of his or her term, the board member shall return the file cabinet to the District.
- 9. Office supplies will be obtained from the central office. A board member will not be reimbursed for the purchase of any supplies by that board member without prior approval of the board.
- 10. Actual and necessary expenses for long distance telephone calls and broadband internet access will be reimbursed when approved by the board. Installation and monthly charges for a broadband internet connection that is to be used exclusively for communication with constituents, internet access, and other board business will be reimbursable. Bills are to be submitted to the District.
- 11. A computer meeting the "district standard" shall be loaned to each requesting board member during his or her term of office to assist in fulfilling their responsibilities as a board member. Upon retiring from the board of Education, the board member will be offered the opportunity to purchase the loaned computer based on fair market value. Board members will also be offered the opportunity to purchase the computer based on fair market value should the computer be replaced during their term of office. Such sales must be approved by a two-thirds vote of the entire board.

#### HIGHLIGHTS FROM THE EXIT SURVEY

- The number of students who plan to continue their education after high school has remained constant the last two years. There was an increase from 88.5% in 2005 to 94% in 2007 and 2008.
- Ninety-eight percent of students with 3.0-4.0+GPA predicted they would be full or part time students
- Eighty-four percent of students with a GPA below 2.0 plan to be a full or part time student. This is an increase from 67% in 2007.
- The number of students who are unsure of their plans has decreased from 34% in 2007 to 26% in 2008.
- A slight majority (56%) feel they took the most challenging courses which they were capable of taking. Twenty nine percent of MLC graduates report taking challenging courses.
- A close correlation exists between those who felt that they took the most challenging courses of which they were capable (56%) and those who report that they took at least one A.P.® course (56%).
- The percent of students who took an A.P.® exam increased from 36 to 40.
- The percent of students who graduate feeling prepared for their post secondary plans is gradually increasing each year.

# POSTGRADUATE (2007) ASSESSMENT—ONE-YEAR STUDY Responses of the class of 2007 collected in June of 2008



#### HIGHLIGHTS AND RECOMMENDATIONS

A vast majority of the class of 2007 (87%) is continuing their education. Well over half of those in school (79%) are also working at least part time while they are in school. The majority reported feeling adequately prepared by the Millard High Schools to achieve their educational goals and/or to enter the workforce. They perceive the courses they took to have been useful or very useful in that preparation. They also reported that their high schools did help them achieve life skills goals, especially the skills to work with others to accomplish tasks and to display personal responsibility. The respondents have very positive feelings about their high schools, especially the teachers, and offered few suggestions for improvement.

Nine in every ten of the respondents to this survey report spending all four years of their high school career in the Millard high school from which they graduated. Education in Millard is their only frame of reference. Millard will need to continue to analyze best practices of other school districts to insure that graduates are well prepared for their futures.

The following observations will be useful to parents, advisors, and counselors as they work with students to complete Personal Learning Plans:

- A strong correlation appears between grades earned in high school and plans to obtain advanced degrees: that is, the higher the high school GPA, the greater the expressed desire to obtain a higher level of education. Seventy-nine percent of graduates questioned who had a GPA of 4.0 or higher said that they hoped to obtain a master's degree or higher compared to only 43% of those who reported a GPA below 3.0.
- Students with a high GPA and participation in activities are more likely to identify courses/programs that prepared them for their future, more likely to attend a four-year college and are more likely to aspire for advanced degrees. In addition, they are more likely to view their employment at one year after graduation as temporary and label it as a training/internship program.
- Thirty-one percent of the graduates report changing their career goal since graduation.
- Of the students who are working full-time and not participating in post-secondary education, 43% could not identify courses/programs that were helpful in preparing them for their current position. In addition, these students view their employment at one year after graduation as permanent.
- Sixty-six percent of those surveyed took an Advanced Placement<sup>®</sup> course, 45% took an Advanced Placement<sup>®</sup> exam, and 32% received college credit or had college courses waived because of taking an AP<sup>®</sup> exam.
- While the voting participation has more than doubled between 2004 and 2007, it is still relatively low about one fourth of the registered voters among the class of 2007 actually voted when they could have.

#### Background and objectives of the research

This is the sixth wave of the one-year postgraduate study conducted by Weise Research Associates on our behalf. This survey was conducted with the graduates of 2007 from all three Millard high schools. The previous waves of this study were done with the classes of 1998, 2000, 2001, 2003 and 2005. The primary objective of each study was to evaluate graduates' perceptions of their experiences with the Millard high school they attended in terms of preparing them to complete post-high school education or to enter the workforce. For the 2005 and 2007 surveys we increased the sample size from 300 to 400 graduates.

#### The specific objectives included

- Evaluate 2007 graduates' current status in terms of employment and post-high school education
- Explore perceptions regarding the impact of Millard high school programs on graduates' current employment
- Assess the impact of Millard high school programs in preparing graduates for postsecondary education
- Gain an understanding of graduates' perceptions of the impact of the courses offered by the high school they attended on preparing them to achieve educational goals and/or to secure employment
- Explore the reason(s) for reported non-participation in extra-curricular activities

### I. Sample characteristics

The total sample in this wave is 400 completed interviews. Each sample was drawn to proportionately represent the actual graduate population distributions by high school. For each study administration, telephone interviews were conducted for approximately 8 minutes with each respondent. The questionnaires are essentially identical, with a few questions related to International Baccalaureate (IB) and Advanced Placement<sup>®</sup> (AP<sup>®</sup>) programs/exams and *two* open-ended questions related to non-participation in extracurricular activities added for the last two surveys. Interviews for this survey were conducted in June 2008.

# II. Employment and education status upon high school graduation and at the time of the survey

A new question in this year's study attempted to gain insight into whether 2007 Graduates anticipated furthering their education or entering employment immediately upon graduation. Ninety-six percent of 2007 Graduates expected to continue with their education upon graduation, 87% are currently doing so. The fact that 87% of 2007 Graduates are continuing with their education one year after high school graduation is similar to the results seen in each of the previous study administrations. A high correlation exists between one's high school grade point average and the likelihood to pursue a higher education one year after high school. Those interviewed in the current study wave were also similar to previous graduates interviewed in terms of their stated occupational or career goal one year after high school. 2007 Graduates were just as likely to have changed their occupational goals one year since high school as were graduates from each of the previous studies with roughly about one-third from each study wave doing so.

### III. Impact of Millard's high school programs on current employment

Seventy-nine percent of the 2007 Graduates interviewed are either working exclusively or in conjunction with pursuing a higher education. The vast majority of 2007 Graduates currently employed feel that they were adequately prepared through their Millard high school to seek employment. Although a wide variety of occupations were mentioned by those who are currently employed, *food/beverage service, marketing/sales*, and *childcare/child development* positions lead the way.

Two-thirds of working graduates interviewed this wave considered their current employment status to be temporary rather than permanent or a training program/internship. This result is slightly lower than what was seen in the past three study waves. As in past waves, those with relatively higher Grade Point Averages (G.P.A.'s) less often considered their current job to be permanent versus those with lower high school G.P.A.'s. A significantly greater proportion of those questioned this year who had a high school G.P.A. of 4.0 or over consider their current position to be a training program or internship versus those with lower high school G.P.A.'s.

In terms of the high school programs or courses that prepared these students for their current occupation, no one particular type of program or course stands out among 2007 Graduates. *Math, business ethics/business*, and *English/Career English* classes were volunteered most often each by 10% of the 2007 Graduates questioned. Forty-three percent of 2007 Graduates, who are currently working full-time, were unable to volunteer a specific program or course that helped them to prepare for their current occupation. This was found to be particularly true among Millard South Graduates (51%) in this current study wave.

# IV. Impact of Millard's high school courses on preparation for post-secondary education

The vast majority of 2007 Graduates who are pursuing a higher education one year after high school are attending a four-year college. This was also true among each of the previous study wave graduates who are furthering their education. Also consistent with findings in the previous five waves, most 2007 Graduates who are attending a post-secondary institution are doing so within the State of Nebraska. The University of Nebraska at Lincoln "topped" the list as far as attendance among 2007 Graduates pursuing higher education, followed by the University of Nebraska at Omaha and Metropolitan Community College.

*Business* was the major course of study volunteered most often among 2007 Graduates questioned. This is primarily comprised of students who obtained less than a 4.0 G.P.A. during high school. As was the case in each of the previous study waves, it appears that 2007 Graduates who are pursuing their education further have a wide variety of major courses of study as illustrated by the fact that only very small segments of these

respondents volunteered any one specific major course of study. As in previous waves, the majority of respondents in this current wave hope to achieve a level of education *beyond* a Bachelor's Degree. Finally, the vast majority of 2007 Graduates who have determined the major of study felt that they were adequately prepared through the Millard high school they attended for entering their current post-secondary educational experience.

# V. Utilization of Advanced Placement<sup>®</sup>/International Baccalaureate Courses and usefulness of general curriculum courses in preparing students

In this current study, graduates were asked about their experience with Advanced Placement<sup>®</sup> courses and exams. Sixty-six percent of 2007 Graduates did take advantage of the AP<sup>®</sup> courses offered by their Millard high school with 45% having actually taken the exam and 32% of the total 2007 Graduates being projected to have received college or university credit or had college courses waived because of taking an Advanced Placement<sup>®</sup> exam.

Fifteen percent of Millard North Graduates interviewed in this current study stated that they had taken an International Baccalaureate (IB) course while attending Millard North. This is slightly lower than what was seen among 2005 Graduates (21%). Overall, 7% of Millard North Graduates of 2007 would be projected to have taken an IB exam specifically, while 4% had a college course waived or received college credit by doing so.

Another objective of this study was to evaluate the impact of Millard's high schools on helping students achieve 15 goals that the District hopes students attain to assist them in their work or educational pursuits after high school. The District does appear to have had a strong impact in helping most students achieve the 15 goals evaluated in each wave as evidenced by the fact that the majority of goals tested received a mean rating of 8.0 or greater based on the 10-point scale where "1" means *High School Had No Impact* and "10" means *High School Had A Great Impact*. The District appears to have been most successful in helping students achieve *reading skills*, *working with others to accomplish goals/tasks*, *speaking skills*, *exposure/computer use*, *working relationships*, *demonstrate responsibility*, *writing skills*, and *positive current career*. The ratings seen among 2007 Graduates for the goals tested have decreased just slightly when compared to 2005 Graduates' ratings.

With regard to which high school courses were most useful to 2007 Graduates in preparing them for their current educational or occupational situation, *English*, *oral communications*, and *mathematics* emerged as the "top three." These programs also "topped" the list as being most useful among graduates in each of the five previous study waves.

### VI. Perceived Strengths of Millard's High Schools and suggested improvements

When respondents in this current study were asked to complete the statement: "I believe the greatest strength of the Millard high school I attended was...," nearly three in every ten (28%) of the 2007 Graduates volunteered teachers (concern, relationships, quality). This was also the "top" strength mentioned most often by graduates in each of the previous study waves. No other specific perceived strength was volunteered by more than 8% of the 2007 Graduates interviewed. The only noteworthy difference by high school was with regard to courses offered where 13% of Millard North Graduates volunteered this as a strength compared to 4% of Millard South and 5% of Millard West graduates.

At the end of the interview, all respondents were asked to complete the following statement regarding any suggestions for improving the Millard high school they attended: "The one thing that could be changed to make Millard's high schools better is...". Nearly three in every ten respondents in this current wave (28%) were unable to think of any specific suggestion for improving Millard's high schools. This result is similar to what was seen in each of the previous study waves. Among those who were able to volunteer a specific improvement, more class choices (7%), improve teachers/teaching strategies (5%), and concentrate on college prep/explore (4%) were volunteered most often.

### VII. Registration for voting and reported voting practice

A majority of 2007 graduates (65%) stated that they were registered to vote at the time of the survey, but only 26% of 2007 graduates reported that they did actually vote in the last election. In 2005, 62% of the graduates were registered to vote and 24% voted. In 2003, the first year that voting questions were asked, 57% were registered and 11% voted.


















