A meeting of the Board of Education of the School District No. 17, in the county of Douglas in the state of Nebraska was convened in open and public session at 6:00 p.m., Monday, September 20, 2021, at the Don Stroh Administration Center, 5606 South 147<sup>th</sup> Street. This meeting can also be attended by videoconference through "ZOOM" with access available to the public and media. The Zoom link was <https://mpsomaha-org.zoom.us/j/95039922838>, and was posted on the district website.

Notice of this meeting was given in advance thereof by publication in the Daily Record on Friday, September 17, 2021 a copy of the publication is being attached to these minutes. Notice of this meeting was given to all members of the Board of Education and a copy of their Acknowledgement of Receipt of Notice and the agenda are attached to these minutes. Availability of the agenda was communicated in advance notice and in the notice of the Board of Education of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

President Linda Poole announced that the open meeting laws are posted and available for public inspection and asked everyone to join in the Pledge of Allegiance.

Roll call was taken. Mr. Kennedy, Mr. Pate, Mr. Anderson, Mrs. Poole, Mrs. Jolley and Mrs. McGill Johnson were present.

Mrs. Poole announced this is the proper time for public questions and comments on agenda items only. Mrs. Poole shared some protocols for speaking at a board of education meeting.

Mrs. Jolley provided a summary of the September 13, 2021 Committee of the Whole Meeting.

**Superintendent's Comments:**

Dr. Sutfin welcomed the three high school student board representatives. Dr. Sutfin said today was the dedication of the mural on the back of the Buell stadium scoreboard. Dr. Sutfin said he appreciates all the people involved in the creation of the mural and the private donors who make this project possible.

**Board Comments:**

Mike Kennedy:

Mr. Kennedy said the mural project is a wonderful project for our community. Mr. Kennedy said passionate parents make a strong district. He appreciates the parents for coming tonight.

Mike Pate:

Mr. Pate welcomed the student board representatives. He said the board welcomes their comments and feedback on items. Mr. Pate thanked the speakers for coming tonight. Mr. Pate said his opinion has not changed and he continues to believe masks should be optional.

Dave Anderson:

Mr. Anderson welcomed the student board representatives and said their input is valuable. Mr. Anderson said he will be watching the data and will do whatever is needed to keep classrooms open. He said he is pro-option for parents but not at the risk of others if the cases are trending up. Students with compromised immune systems continue to be a concern for him.

Stacy Jolley:

Mrs. Jolley thanked all the people who attended tonight. Mrs. Jolley spoke about how extraordinary the new mural at Buell Stadium is. Mrs. Jolley said she had a great time celebrating the art by Watie White and thanked Marian Fey, Clarke Community Initiative, Millard Public Schools Foundation and all the donors who made this project possible.

Amanda McGill Johnson:

Mrs. McGill Johnson thanked everyone who came out tonight and spoke. Mrs. McGill Johnson said she had the opportunity to visit Black Elk elementary to discuss the unicameral. She said it was refreshing and great to see how things were going.

Mrs. Poole:

Mrs. Poole said she was recently re-appointed to the Governor's tactical advisory for statewide assessment. Mrs. Poole also shared that at the last Millard Public Schools Foundation meeting it was shared that the KidsNet numbers have continued to increase. She said KidNet continues to struggle with staffing. Mrs. Poole also shared details for the upcoming Jingle event on November 18, 2021.

Mrs. Poole said she also had the opportunity to attend the mural dedication event today and said it was an amazing event. She said she was part of the vision team and said it was wonderful to be part of the process. Mrs. Poole thanked everyone who contributed.

Ava Hollingsworth, student representative from Millard North High School, and Pamela Abalekpor, student representative from Millard South High School, and Katie Reynolds student representative from Millard West High School reported on the academic and athletic happenings at their respective schools.

## **Reports:**

### **Facilities Report**

Chief Financial Officer Chad Meisgeier introduced Facilities Director Shelly Kaup who started during the pandemic. Mr. Meisgeier said she has done great work. Mrs. Kaup said the facilities management protocol has remained very similar as last year for this school year. She said the 195 employees in her department have done a phenomenal job handling COVID-19. Mrs. Kaup said they have found a new product that is both a cleaner and disinfectant. The new product provides significant cost savings. Mrs. Kaup shared that in an effort to be more environmentally friendly, we have made changes to the toilet paper and paper towels used in the district. This also provides additional savings since we have also transitioned to universal dispensers district wide.

Dr. Sutfin asked Mrs. Kaup to share about how the recent TikTok challenge is affecting our high schools. Dr. Sutfin explained that the 'lick' challenge encourages students to steal or vandalize school bathrooms and record doing so. Mrs. Kaup said they have had roughly two hundred soap dispensers that have had to be replaced or reinstalled due to this challenge. Dr. Sutfin said we are working with the police and that this is a nationwide problem. Dr. Sutfin said this challenge has cost us roughly \$10,000.00. Dr. Sutfin asked parents to talk to their students and help us stop this.

### **Enrollment Report (Beginning of Year 2021)**

Dr. Darin Kelberlau, Executive Director of Assessment, Research and Evaluation, shared the enrollment report and indicated the beginning of the year numbers. This data was pulled on August 26, 2021 and our PK-12 enrollment numbers are 23,864. The official NDE numbers will be pulled 10/1/21 and he will bring another report after that date.

### **Legislative Update**

Executive Director of Activities, Athletics & External Affairs Nolan Beyer provided the board with a legislative update. Mr. Beyer said today is day six of the special session. The special session is scheduled for 12 days for the purpose of redistricting. Last week they held three days of hearings. Last Friday they began debate on LB1 which were the congressional districts. After 8 hours LB1 was filibustered and did not advance. This map is being referred to as the "Linehan" map. The alternative map is being referred to as the "Wayne" map and was brought as an amendment. This map never got to a vote.

Today they debated on the legislative districts map. Mr. Beyer assumes they will have the same outcome. He said a great part of today's debate was regarding who would lose a district in the rural part of the state. Mr. Beyer said the Speakers shared his concern on how little they were getting done. Tomorrow they will come back and discuss the congressional maps.

Mr. Beyer said the public hearings were well attended. Mr. Beyer also said he anticipates lots of compromising will happen before they agree on a map.

### **Superintendent's Comments and District Update**

Dr. Sutfin said that he has provided a district update at every board meeting since the beginning of COVID-19. Dr. Sutfin provided the board with an update on how the district is responding to COVID-19. Dr. Sutfin said masks remain strongly recommended. Dr. Sutfin asked parents to not send students to school when sick. Dr. Sutfin reminded parents to not send the siblings of your children to school if one of them is positive for COVID. They will be required to monitor at home. He also asked that parents do not send your child to school if they are awaiting the results of a COVID test.



Dr. Sutfin shared the current guidance received from Douglas County Health regarding response to positive cases. This guidance is what we are currently following. He explained the specific guidance in relation to elementary age students as well as secondary age students. Dr. Sutfin also explained what the district is doing to combat COVID-19 within our schools. Dr. Sutfin shared our current plan. There is no debate that in-person instruction is best for students' academic, emotional, and social growth. He said masking is somewhat disruptive to the classroom. However masking is not as disruptive as a classroom closure. Dr. Sutfin said our numbers continue to trend down.

Dr. Sutfin said our goal remains the same, which is to keep our classrooms and schools open for in-person learning. Dr. Sutfin said we will make decisions that keep our schools free from disruption by analyzing current cases, current cases by location, and frequency of cases over time in a specific location.

Dr. Sutfin shared the available data from Douglas County on the 7 day rolling average, percent of cases by age groups and zip code, hospitalization and ventilator usage. Dr. Sutfin also shared the data on the number of fully vaccinated residents.

Dr. Sutfin shared the Millard data on the total positive cases, including a breakdown by level. Dr. Sutfin also shared the breakdown of positive cases in MPS under the age of 12 as well as above age 12.

Dr. Sutfin shared that positive case numbers information can be found on the COVID dashboard on the district website. Positive cases by school can also be found on the website. These numbers include positive cases for students and staff.

Dr. Sutfin said the mental wellbeing of our students is a topic of discussion. He shared many topics around COVID and anxiety/depression such as instability through loss (food insecurity, income, eviction, family member) which can cause anxiety or depression. Dr. Sutfin said many of these instabilities through loss are not just COVID related and we as a district have addressed them for some time. He said we have a caring staff with many licensed professionals to assist with this process. Dr. Sutfin said currently, there has been no statistical correlation found between mask wearing and anxiety/depression. We are still looking and researching this topic.

Dr. Sutfin said we anticipate vaccines will be available for those under age twelve in late October. Dr. Sutfin said we encourage parents to discuss vaccine options with your physician. Dr. Sutfin said we will work with Douglas County Health to devise a plan to provide vaccine clinics to the community. Dr. Sutfin said the goal is to provide easy and fast options for parents who want their students vaccinated.

Mrs. Poole reminded the Board of future agenda items and said this is the proper time for public questions and comments. There were no requests to speak on non-agenda items.

## **Committee Meeting Minutes October 11, 2021**

The members of the Board of Education met as a Committee of the Whole on Monday, October 11, 2021 at the Don Stroh Administration Center, 5606 South 147th Street.

Board Vice President, Dave Anderson called the meeting to order at 6:00 p.m. Mr. Anderson announced that the open meeting laws are posted and available for public inspection and it is now the proper time for public questions and comments on agenda items only. There were no requests to speak.

Board members present were: Linda Poole, Dave Anderson, Amanda McGill Johnson, Stacy Jolley, Mike Pate, and Mike Kennedy.

### **HR Staffing Update**

Associate Superintendent of Human Resources Dr. Kevin Chick said tonight he and his team will provide an update on staffing. Dr. Chick introduced his team; Director of Personnel Mitch Mollring, HR Recruiter Jeanine Beaudin and HR Generalist Karen Porter.

Mr. Mollring shared that 133 new teachers were hired for 2021-22. He said we currently have two open positions which are foreign language positions. Mr. Mollring also said 126 substitute teachers and 94 paraprofessionals have been hired since June. Dr. Chick said we continue to struggle with filling para and food service positions. Mr. Mollring said we continue to see a limited candidate pool for all certified secondary areas, special education, paraprofessionals, food service and van drivers.

Mrs. Beaudin shared the current hiring practices which include attending job fairs in person and via Zoom as well as posting and hiring sooner. She said we continue to offer a \$1,000 signing bonus as well as a competitive starting salary. Mr. Mollring also shared how they are retaining staff by offering a wonderful onboarding and new staff induction. Mr. Mollring also said scholarship funds are available for teachers to continue their education. Mrs. Beaudin said they are working directly with UNO, College of St. Mary, Peru State, and MCC to hire current university students as paraprofessionals in our critical needs classrooms on days that work around a college schedule.

Mr. Mollring said we have 529 active subs with 150 that have yet to work a day this school year. He said we have one average 110 subs work each day and we have a current fill rate of 91%. Mr. Mollring said they have increased sub teacher pay and are also offering giveaways for subs working on Mondays and Fridays.

Mrs. Porter shared the ways they are recruiting for hourly staff positions. Some of these are by promoting Millard Public School and encouraging people to apply by attending events like Millard Days, Millard high school football games and hosting job fairs. Mrs. Porter said they have increased their signage to promote Millard Public Schools which include yard signs, fence banners and vehicle decals. Mrs. Porter said they have also increased their presence on social media.

### **Legislative Update**

Executive Director of Activities, Athletics & External Affairs Nolan Beyer provided the board with a legislative update. Mr. Beyer said several interim studies took place during the special session. Mr. Beyer highlighted those that could have an effect on public education or Millard Public Schools:

- Appropriations Committee
  - LR178 Interim study to solicit input from Nebraskans regarding funds from the federal American Rescue Plan Act of 2021.
  - LR179 Interim study to examine funding mechanisms in the American Rescue Plan Act of 2021.
- Education Committee
  - LR180 Interim study to examine the identification of at-risk and economically disadvantaged students as a qualification factor for state-funded, education-related programs.
  - LR182 Interim study to examine the school enrollment options available to students.
  - LR149 Interim study to examine the potential for statewide early childhood autism spectrum disorder screening.

- Revenue Committee
  - LR261 Interim study to examine the structure and administration of and compliance with certain taxes.
  - LR230 Interim study to examine a potential constitutional amendment to limit property taxation to residential property only.

Mr. Beyer said the legislative districts map has been approved. Mr. Beyer provided the board with copies of the new maps. Mr. Beyer does not think the changes will have much impact on Millard.

#### **District COVID Update**

Dr. Sutfin provided a district COVID update on how the district is responding to COVID-19. Dr. Sutfin said currently we have 71 students and 6 staff members with COVID-19.

Dr. Sutfin said we continue to mask classrooms that have one positive case. If there is a cluster of three or more in a classroom we close the classroom. Dr. Sutfin said we anticipate vaccines will be available for those under age twelve between late October and Thanksgiving.

Dr. Sutfin said we have hosted several flu shot clinics for our staff. Dr. Sutfin said communication went to staff regarding the Pfizer vaccine boosters availability and encouraged staff to talk to their doctor regarding it.

At 6:52 p.m. Stacy Jolley made a motion to go into Executive Session, seconded by Mike Pate. Voting in favor of said motion was: Mr. Kennedy, Mr. Pate, Mrs. Poole, Mr. Anderson, Mrs. McGill Johnson and Mrs. Jolley. Voting against were: None. Motion carried.

Motion by Mike Pate and seconded by Linda Poole to come out of Executive Session at 7:20 p.m. Voting in favor of said motion was: Mr. Kennedy, Mrs. Jolley, Mr. Pate, Mrs. Poole, and Mr. Anderson. Voting against were: None. Motion carried. Mrs. McGill Johnson was absent from executive session.







**Background/  
Description:**

On August 11, 2003, Millard Public Schools approved the first dual enrollment options for students. Through this opportunity, students enroll in select Advanced Placement<sup>®</sup> courses, take the course for high school credit and, at the same time, pay tuition and receive transferable credit through UNO.

Dual enrollment opportunities now include several non-Advanced Placement<sup>®</sup> courses at UNO and courses completed through Metropolitan Community College (MCC) by participation in a Millard Career Academy, an MCC Career Academy, or Early College. The ability to offer dual enrollment varies for each building every year based on teacher credentials and the criteria established by UNO and MCC.

The total savings through UNO and MCC due to reduced tuition of \$1,791,105 benefits students and their families. The MPS Foundation paid \$20,280 for Early College Scholarships in 2020-2021.

The MPS Foundation has allocated funds to pay for tuition for students in the Early College Program qualifying for Free or Reduced Priced Lunches for the 2021-2022 school year.

Students who took MCC Academy courses, or MPS Academy courses of Emergency Medical Technician (EMT), or Accounting paid \$38.00 per credit hour. MCC tuition for a full time student is \$71.00 per credit hour. This represents a savings of \$384,817 for the 6671.5 MCC credits earned by Millard academy students.

Early College dual enrollment tuition at Metropolitan Community College was \$38 per course. MCC tuition for a full time student is \$71.00 per credit hour. This represents a savings of \$875,183 for the 13,990 MCC credits earned by Millard Early College participants.

The combined savings for all MCC dual enrollment opportunities is **\$1,260,000** for the 20,661.5 MCC credits earned by Millard students in Millard Career Academies, MCC Academies, and Early College.

Millard students scored a 3, 4, or 5 at a rate of 63% (the same percentage as last year) compared to the state average of 60% and the global average of 58% which were drops.</li> <li>● The number of students taking an AP Exam decreased by 43 students, but the number of exams completed decreased by 122.</li> <li>● The number of AP Scholars remained strong with 436 students named as AP scholars as a result of 2020-2021 testing.</li> <li>● The financial support provided by the Millard Public Schools Foundation continued to assist in the exam costs taken during the 2020-2021 school year.</li> <li>● Beginning with the 2016-2017 year, the Foundation no longer funds AP Exams for courses that we do not offer or for courses in which a student is not enrolled.</li> <li>● In 2020-2021, there was a cost-sharing plan for AP Exams implemented. Students paid \$40 of the cost of the exam (\$95) and students who qualify for Free and Reduced Price Lunch paid \$23 of the exam cost (\$62). ## Points of Interest

Millard continues to have a strong AP culture, offering twenty-six Advanced Placement courses with over 4000 AP courses completed in the 2020-2021 school year. Although the total number of tests taken in Millard decreased slightly in 2020-2021, students that did take the tests still performed well. Over seventeen hundred students chose to challenge themselves by taking 2735 tests with 63% of the tests scoring in the 3, 4, or 5 range. Millard students accounted for 19% of the total Advanced Placement tests taken in the state of Nebraska and 436 students were recognized as College Board Scholars.

The 2009 Strategic Plan including Strategy 2, Action Plan 3 call to actively engage students, families and staff to improve student achievement and attain personal excellence, and Strategy 4, Action Plan 4 to utilize instructional best practices, formative and summative assessments, and student data designed to ensure high achievement for all students and all demographic subgroups, which both support promoting personal excellence, increasing student achievement, and engaging students. Advanced Placement® courses provide the opportunity for students to achieve personal excellence by engaging in rigorous courses. In the 2018 Strategic Plan the parameter “We will always expect each student to set and achieve challenging educational and career goals tailored to his/her abilities, interests, and aspirations.” was added to emphasize this continued focus.

## **Advanced Placement® Courses**

Advanced Placement® Courses follow the curriculum recommendations of the College Board. The course and corresponding exam provide for a rigorous, fast paced, college level class. During the 2020-2021 school year, Millard offered 26 Advanced Placement® courses. Courses are listed below with the number of exams taken.

Students may elect to take exams even though the District does not provide a corresponding course. Eleven non-course exams were completed by Millard students during 2020-2021.

Examples this past year included: Chinese Language and Culture (2), Physics C: Electricity and Magnetism (3), Physics C: Mechanics (6).

### **Student Course and Test Enrollment**

Overall, there has been an increase in completion of Advanced Placement® classes since the AP Plan was implemented. Both AP course enrollment and exam completion decreased in the 2020-2021 school year as noted in the chart below. The focus of testing is to provide students the opportunity to take a national test, which is utilized as a measure to predict success in college. Students may compare their test results with students nationally who are taking the same exam.

The chart below shows the number of students as a district who completed AP courses compared to the number of exams taken as a result of participation in the provided courses.

During the 2020-2021 school year, 1736 students took 2735 AP Exams. This represents a decrease of 43 students and a decrease of 122 exams from the 2019-2020 school year. The number of students

These grade categories are designed to reflect achievement scores in the AP course that is analogous to performance in a comparable college course. 63% percent of the exams taken by Millard students had a score of 3, 4 or 5 in 2020-2021 the same as in the 2019-2020 school year.

### **MPS Foundation Advanced Placement® Support**

The financial support provided by the Millard Public Schools Foundation continued to assist in paying for exams taken during the 2020-2021 school year. The cost of taking an AP exam in 2020-2021 was \$95.00. Beginning with the 2011-2012 school year, the Foundation paid for all AP exams for which students completed a class and were not funded through UNO Dual Enrollment course registration. Due to the effects of the COVID-19 pandemic impacting revenue sources for the MPS Foundation the following cost sharing model was put into effect in 2020-2021: Exam cost \$95, students paid \$40 and the MPS Foundation paid \$55. For students who qualify for Free and Reduced Lunch Prices the exam cost was \$62 with the student paying \$23 and the MPS Foundation paying \$39.

## **STUDENT DISCIPLINE**

The goal and intention of the District is to enable students to obtain an education within a safe environment, free of violence or the threat of violence, illegal drugs, alcohol, weapons, or any conduct which interferes or disrupts the educational process.

Each school year an emphasis is placed on consistent reporting. To help ensure data is reported consistently, monthly student discipline meetings are held with building principals and assistant principals. An alphabetical listing of “events” complete with detailed definitions was created in 2008 and is annually shared with each building administrator. This “event” listing is reviewed annually by the discipline committee and can also be found in the student information system (SIS). Each time a behavior is entered into the SIS, the list can be easily accessed electronically to ensure the correct “event(s)” are being entered into the system. The reported codes mirror those codes reported to the Nebraska Dept. of Education.

### **Student Code of Conduct**

The Standards for Student Conduct (Rule 5400.6) defines the disciplinary rules for the Millard School District. These rules are uniform across the District and are approved by the Board of Education each school year. The Standards for Student Conduct are published in the student handbook by each building and are reviewed with students annually. All students are required to acknowledge receipt and understanding of the Student Code of Conduct.

### **Drugs and Violence Events**

The event categories that were disaggregated for violence indicators include: physical assault, fighting, threats-level one, threats-level two, and threats-level three, bomb threat, physical injury, guns, and other weapons. “Firearms” refer to all types of guns including pellet, air-soft, paint ball, stun guns and BB guns. This data is cyclical when compared to data gathered over the past three years.

Acts of threats or violence directly impact school safety and must be addressed by District discipline procedures as well as safety programs. We strive to identify students who have violent tendencies so they are monitored and placed in appropriate educational programs as needed and required by law.

### Repeat Offenders

In 2020-21 there were 2,036 students with four (4) or fewer discipline events. When repeat events were disaggregated, it was found that 197 students had between 5-9 events. ### **Connections Student Health Referrals**

Connections through Project Harmony is a voluntary mental health referral program that provides our school social workers with a single point of referral for families and students in need of mental health support. Connections coordinators work closely with school staff and contracted therapists to identify needs and to match those needs with the appropriate providers. Students and families are typically "Connected" with a mental health provider within 24 hours and can stay connected with that provider for as many as sixteen visits. Beginning in February 2018, Millard Public School and The Child's Respite Care Center (CRCC) entered into a partnership that placed three on-site mental health therapists in each of our high schools. The therapists provide an in-house point of referral for our social workers and counselors who may be working families and students in need of this type of assistance. Our school based therapy is optional for families and any in-school sessions are scheduled around core instructional periods.
